1. Call to Order

Mayor Anzevino called to order the workshop of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22, and he handed the workshop over to President of Council Foster, in accordance with Council Rules.

2. Correspondence and Council Comments

Mr. Sutton provided an update on the Fiber to the Residents Subcommittee meeting that was held prior to this meeting.

Mr. Ruffer stated that Mrs. Heater and he will hold a Meet and Greet at the Hudson Library on October 4, 2023 from 6:30 p.m. to 8:00 p.m. and invited interested citizens to attend.

Mayor Anzenvino provided an update on a meeting that City staff and he attended with the pack master of Boy Scout Troop 321, as well as an update on the MAPS meeting that Mr. Sheridan and he attended earlier today. He further reminded citizens that October 10, 2023 is the deadline to register to vote in the upcoming November election.

3. Discussion Items

A. <u>23-0095</u> Hudson Community Television Advisory Committee Goals and Objectives

Brief Description: At the request of City Council, the HCTV Advisory Committee has prepared an update on their ongoing goals and objectives of the committee.

Mr. Zaklanovich, Chair and Mr. Miller, Vice Chair, of the HCTV Advisory Committee provided an update on the goals and objectives of the committee. The goals included improving social media awareness, utilizing the technology subcommittee to research equipment needs and upgrades to station equipment, and expansion of committee involvement with the annual community media event.

B. <u>23-0096</u> Proposed Land Development Code Text amendment relative to the regulation of Vape Shops, Pawn Shops, and Tattoo Parlors.

Mr. Hannan stated that he will express Council's concerns to Farmer's Rail and work with them to place the dumpster as close to their pedestrian door as possible. There was Council consensus to remove this item from further consideration.
