# MEETING MINUTES March 5, 2024 – 9:00 a.m. City Hall – City Manager's Conference Room

*Address:* 102 First Street, Suite 201, Hudson, OH 44236 *Presenting:* No representative from business in attendance

Discussion: Mrs. Behnke summarized the incentive is a 50%, six-year Jobs Creation Grant in its fifth year of review. Ms. Behnke explained that she had exchanged notes with Greg Kleeh, Chief Operations Officer, who acknowledged that the payroll was significantly below their commitments due to changes in their remote work policy following the pandemic. The company reported 52% of the payroll that was originally forecasted at the time the incentive agreement was executed. The group discussed this situation and determined that since a Job Creation Grant does not payout unless 75% of the commitment is made, there is no risk to the community to allow the grant to complete its final year in 2024 in order to maintain the relationship with the business.

*Discussion:* Mrs. Behnke summarized the incentive is a 50%, ten-year Jobs Creation Grant in its second year of review. The 2023 headcount and payroll dollars both exceeding the commitments in the agreement. Mr. Genger noted the have maintained a hybrid schedule for most positions but require new employees to report into the office for their first one hundred and twenty days.

*Discussion:* Mrs. Behnke summarized the incentive is a 50%, nine-year Jobs Creation Grant in its first year of review. The 2023 FTEs and payroll dollars exceed the commitment. Mr. Vinci confirmed that employees are fully in the office, only working remotely for about three months during the pandemic. He noted more willingness from candidates to take roles that in the office full time than even a year ago.

*Discussion:* Mrs. Behnke summarized the incentive is a 50%, ten-year Jobs Creation Grant in its second year of review. The 2023 FTEs met the commitment and the payroll dollars exceeded the commitment. Mr. Salm noted that their employees are in the office four days a week and remote on Fridays.

*Discussion:* Mrs. Behnke summarized the incentive is a 100%, fifteen-year Community Reinvestment Area in its sixth year of review. The business is short of the FTE commitment for 2023 but has far exceeded the payroll commitment. Mr. Henison noted that the company is testing creative ways to continue bringing their workforce back to the office including bringing new hires nationally to headquarters for their first week, in office trainings on new technology, and developing a Train the Trainor program taught at headquarters.

*Discussion:* Mrs. Behnke summarized the incentive is a 100%, fifteen-year Community Reinvestment Area in its sixth year of review. This property has far exceeded the FTE and payroll commitments in each of the six years reviewed. The current tenants have leases expiring in 2027 and 2028.

Ms. Cordell noted that they are finally fully staffed following the high demand for nurses throughout the pandemic with just one part-time position open.

*Discussion:* Mrs. Behnke summarized the incentive is a 50%, fifteen-year Community Reinvestment Area in its third year of review. The exceeded the FTE and payroll dollar commitment for 2023. Mr. Carano noted that CEIA is looking to continue their investment on the property with a small building for training.

*Discussion:* Mrs. Behnke summarized the incentive is a 100%, fifteen-year Community Reinvestment Area in its eighth year of review. The business is short of the FTE commitment for 2023 but has far exceeded the payroll commitment. Mr. Businger shared that RAMCO continues to move production capabilities to Hudson from other locations in Michigan and overseas.

Discussion: Mrs. Behnke summarized the incentive is a 50%, fifteen-year Community Reinvestment Area in its third year of review. The business did not meet the FTE and payroll growth committed for their expansion in their agreement. However, the business made significant strides toward achieving the targets compared to their 2022. As discussed in the 2022 review, the company projected it would take between three and five years to reach their agreement commitments following the changes in work styles from the pandemic. Mr. Edwards and Mr. Lewis confirmed that this remains a reasonable timeline. Additionally, Mr. Edwards shared that the company is planning to build an additional pharmacy building on their site which would allow the company to hire an additional pharmacy and four technicians.

The Tax Incentive Review Council further deliberated on the discussions with each business and the following actions were taken:
