A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH QUALITY CONTROL INSPECTION, INC. FOR CONSTRUCTION ADMINISTRATION SUPPORT SERVICES FOR THE VALLEY VIEW ROAD RESURFACING PROJECT (PID 116932); AND DECLARING AN EMERGENCY.

WHEREAS, the Valley View Road Resurfacing Project includes the resurfacing of Valley View Road from the City's northern corporation line, southeast to State Route 91 ("the Project"); and

WHEREAS, the project is being partially funded via an Ohio Department of Transportation ("ODOT") Federal Surface Transportation Block Grant funds and Toll Revenue Credit in an amount up to \$787,500.00; and

WHEREAS, the resurfacing is scheduled to begin this spring with a duration of approximately 60 days; and

WHERAS, due to anticipated, on-going, City project construction management and inspection requirements, City staff anticipates not having availability to cover the full-time inspection and construction administration for the Project as required by ODOT; and

WHEREAS, because of the anticipated construction management and inspection needs, City staff requested and evaluated professional consultant proposals for the Project; and

WHEREAS, since the Project is partially funded with federal grants, personnel performing this work must be either ODOT pre-qualified, or have enough experience as approved by ODOT; and

WHEREAS, City staff requested letters of interest from four (4) ODOT pre-qualified construction management and inspection consultants and determined that Quality Control Inspection, Inc. (QCI) was the lowest cost, qualified consultant at a base fee of \$42,802.12.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1: That the City Manager is hereby authorized to enter a professional services contract with Quality Control Inspection, Inc. for the Valley View Road Resurfacing Project, (PID 116932) and the described construction management and inspection consulting work, in the amount of \$42,802.12, plus a 10% contingency of \$4,280.21, for a total amount of \$47,082.33.

Section 2: That the above recitals are fully incorporated as findings herein.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

<u>Section 4:</u> That this Resolution is hereby declared to be an emergency measure necessary for the timely submission of the necessary paperwork in order to complete this Project, to promote highway safety and/or immediate preservation of the public peace, health, safety and welfare of the community and shall therefore take effect and be in force from and immediately after its passage.
