A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT WITH DEERE AND COMPANY FOR A CONTOUR MOWER FOR THE ELLSWORTH MEADOWS GOLF COURSE.

WHEREAS, the City's existing 2007 golf course contour mower has exceeded its useful life based on age, hours, and wear and tear; and,

WHEREAS, the City of Hudson has the authority to purchase equipment through the State of Ohio Cooperative Purchasing Program, which entity employs competitive bidding processes for equipment; and,

WHEREAS, the City has obtained a price quote from Deere & Company, Cary, North Carolina, an authorized State of Ohio Cooperative Purchasing Program vendor under State Term Contract #OH STS 515 AG, for the purchase of a contour mower for the Ellsworth Meadows Golf Course; and,

WHEREAS, this replacement contour mower is in the 2023 budget for \$68,000 (Budget Item in 2023 – Rotary Rough Mower Replacement), but since the adoption of the budget, the mower price has increased by \$5,541.08; and,

WHEREAS, the total purchase price for this piece of equipment is in a total amount of \$73,541.08; and,

WHEREAS, this Council has appropriated the funds necessary for the purchase of said equipment to replace equipment in the City's Golf Course Division.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

- Section 1. The City Manager is authorized to enter into a purchase agreement with Deere & Company, Cary, North Carolina, under the State of Ohio Procurement State Term Schedule Contract No. STS 515 AG for the purchase of a contour mower to replace the existing 2007 golf course contour mower in an amount not to exceed \$73,541.08, and once said amount has been appropriated in the City budget.
- <u>Section 2.</u> That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.
- Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal
