1. Call to Order

Pursuant to the Charter of the City of Hudson, Sections 4.04 and 3.03, and the Codified Ordinances Section 220.03, in the absence of Mayor Currin and President of Council Basil, Mr. Jeffers, President of Council Pro Tempore, called to order the Council meeting at 7:31 p.m.

4. Approval of the Minutes

The following minutes were approved as submitted.

A. AOM 120801 Special Meeting on July 17, 2012, and Regular Meeting on July 18, 2012.

Public Comments

Mr. John Wysmierski, 2169 Bristol Court, said that with Council's passage of Ordinance No. 12-96, proposing an amendment to the City's Charter to change the filing deadline from 75 days to 90 days, and with voter approval in November, the change will substantially help the Board of Elections in providing ballots to absentee voters sooner. He noted that he is an

employee of the Summit County Board of Elections.

Mr. Will Robinson, 7936 Ravenna Road, spoke in objection to the City funding the use of a consultant for an economic development branding and marketing initiative. He also objected to tax incentives to attract new businesses.

6. Correspondence and Council Comments

Dr. Williams commented that Robinson Landscaping did an outstanding job on the recent downtown beautification project, and he asked Mr. Robinson to extend Council's appreciation to his family, who owns the business.

Mr. Jeffers commented on Congressman LaTourette's recent announcement that he will not run for an additional term in office. He noted that Congressman LaTourette's past efforts to support Hudson have been very beneficial, and he said that Council will need to judiciously re-examine the City's expenditures.

7. Report of Manager

Regarding Ordinance No. 12-108, Mr. Bales noted an error on the list of auction items provided on the July 24, 2012 workshop memo. He said that the list included two 2007 Crown Victoria police interceptor vehicles, and the correct model years for the vehicles are 2005 and 2007.

On behalf of Mr. Basil, Mr. Bales announced the upcoming Ward 2 Open Forum, to be held on Monday, August 13, 2012, at 7:30 p.m. at the Barlow Community Center.

Mr. Bales requested an executive session to discuss pending litigation.
