A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH JEREMY IOSUE AND THE LAW FIRM OF STEFANIK IOSUE & ASSOCIATES FOR SPECIAL COUNSEL SERVICES IN LABOR AND EMPLOYMENT LAW; AND DECLARING AN EMERGENCY.

WHEREAS, the City Manager and staff have researched and determined Jeremy Iosue and the law firm of Stefanik Iosue & Associates should be engaged as Special Counsel for labor and employment law matters; and,

WHEREAS, the City Manager has recommended that City Council authorize a new agreement with Jeremy Iosue and Stefanik Iosue & Associates for the provision of such services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio as follows:

<u>Section 1:</u> That Jeremy Iosue and the law firm of Stefanik Iosue & Associates are hereby appointed as Special Counsel for the City of Hudson, effective May 8, 2024. As Special Counsel, Stefanik Iosue & Associates and/or Attorney Iosue shall represent, counsel, and advise the City of Hudson in all legal matters related to labor and employment law as they are directed to do by the City Manager or City Council. As such, all the City Manager and Attorney Iosue's actions to date on this topic are hereby ratified and affirmed.

Section 2: That the City Manager is hereby authorized to enter an Agreement, effective May 8, 2024, with Stefanik Iosue & Associates and Attorney Iosue for labor and employment law legal services. The authorized agreement to provide such legal services to the City of Hudson is attached as Exhibit "A" and incorporated into this Resolution as though fully rewritten herein.

Section 3: That all prior resolutions and ordinances that relate to or in any way conflict with this measure are hereby repealed and rescinded.

Section 4: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

<u>Section 5:</u> All formal actions of this Council related to this Resolution and all deliberations of the Council and of any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

<u>Section 6:</u> This Resolution is declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the City of Hudson and the inhabitants thereof, and for the further reason that this Resolution must be immediately effective in order to provide for the immediate legal services described herein, which are necessary

to preserve and protect the legal interests of the City of Hudson. This Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
