Ms. Kim Klein, 514 Atterbury Boulevard, expressed concerns regarding development impacts to wetlands and wildlife, as well as run-off affecting Hudson's water supply. She was opposed to the rezoning request.

Mrs. Catherine Hedlund, 111 Stratford Road, questioned the benefit of the proposed zoning change and expressed concerns about traffic impacts.

Ms. Jennifer Grega, 241 Boston Mills Road, inquired if a wetlands impact study had been completed for the subject property. She also expressed concerns regarding traffic impacts and asked questions about property taxes. She was opposed to the rezoning request.

Ms. Eva Marie Loeffler, 430 Boston Mills Road, asked for clarification regarding the location of the new development. She expressed concerns about traffic impacts for vehicles

and bicycles, and she asked about development access from Boston Mills Road and Petit Road in Boston Heights.

Mr. Daniel Saduski and Ms. Marsha Hamilton, 800 Boston Mills Road, said that traffic is already heavy on Boston Mills Road, and they expressed concerns for traffic impacts. Their preference was for the zoning to remain commercial, unless water and sewer lines extended for the development would benefit existing residents along Boston Mills Road. They also expressed concerns regarding the displacement of wildlife.

Mrs. Linda Sangrik, 6956 Post Lane, questioned development impacts to the wetlands and future habitat of nesting bald eagles. She expressed concerns regarding pollution and drainage changes to the area and asked when additional studies will be performed.

Mr. Chris Brown, representing Prestige Homes, thanked Council for hearing comments. He provided background information about the subject property and the proposed residential development. He addressed questions regarding wetlands and said that 316 acres will be set aside in perpetuity in a conservation easement to be overseen by Ohio Stream Preservation of Bainbridge. He also provided information regarding connectivity plans and invited elected officials and the public to contact him with questions.

Mr. Steven Korane, 75 East Case Drive, expressed concerns regarding traffic impacts and asked that Council consider connectivity plans for this area.

Elected officials and staff responded to public comments.

A public hearing was held regarding Ordinance No. 14-19. Mayor Currin opened the public hearing at 7:33 p.m. and closed the public hearing at 8:17 p.m.

6. Public Comments

Ms. Jennifer Grega, 241 Boston Mills Road, inquired regarding the availability of City Council's voting records and supporting materials for Council meetings. Mayor Currin said that Council records are available via the City's website, along with much other information, including agendas, supporting materials, and minutes and video recordings of Council meetings.

Ms. Kim Klein, 514 Atterbury Boulevard, asked who on City Council represents the environment. Mayor Currin responded that all City Council members represent citizens. In addition, he said that the City has an Environmental Awareness Committee, and the Community Development Department considers environmental concerns, as well.
