My wife Jessica and I and our three children (7, 4 and 3) reside at 2078 Ravenna St. and I would like to address the letter sent by the attorney Mr. John P. Slagter representing the property owners Canterbury K Farms LLC and Prestige-Canterbury Farms LLC, the owners of Summit County Parcel Nos. 3010370, 3003108, 3006324, 3002169, 3002375, 3001397, 3004552, 3004555 and Prestige Builder Group, the developer trying to develop the above parcels.

I ask that council **NOT** postpone the sidewalk installation on Ravenna Street that is to run from South Hayden Parkway to Stow Road. There is a major safety issue in this area with the speed limit being 35 mph and not changing to 25 mph until the hill right before South Hayden Parkway when heading west. There is a preschool on this street as well as a public park path that connects to Colony Park. Currently, we encourage people to walk through our front yard vs. walking on the street as there is very little shoulder. The hill mentioned previously compounds the speed and lack of shoulder as it reduces visibility for both the pedestrians, bikers and drivers.

We have no issue with development in Hudson that follows proper zoning regulations and land use requirements. That being said there is no approved development on the parcels above and to postpone the project for an unknown period of time for a potential development that has yet to be approved, seems counterintuitive.

I think it's important to remember that non-vehicular connectivity was a key objective of the 2024 City of Hudson Comprehensive Plan. I don't think we should set a precedent of postponing current objectives and projects that are important to Hudson residents for future unknowns.

This Ravenna Street sidewalk project is already out for bid from our understanding. Please let it continue. I know Jessica and I are excited to have the new sidewalk on our street and for our neighbors and their children to have a safe place to walk and bike.

I am writing not only as a resident of Ravenna Street, but as someone whose daily life is directly and personally affected by the current lack of sidewalks. As a long-distance runner, I use Ravenna Street regularly, and the conditions have become increasingly dangerous. Cars often pass within inches of me, even though I am wearing a light up vest at dawn and dusk, or even during the middle of the day, and without a safe shoulder or walkway, every run from my home feels like a risk. This is not merely an inconvenience—it is a genuine safety concern for me and for others who walk, run, or bike along this road. In fact, I cannot safely allow my children to ride their bikes or walk to school, downtown or to visit neighbors.

I along with my children have been looking forward to our sidewalks for several years now since the connectivity plan of 2021 stated this would be happening.

For this reason, I respectfully request that the Council deny Prestige Developers' request to delay the construction of sidewalks on Ravenna Street. My understanding is that:

- \* There is no approved development for the Sergi property at this time—only a possible interest in pursuing one in the future.
- \* The City Manager has already stated on the public record that the planned sidewalk would not be impacted by any future development of the Sergi property.
- \* If a waterline is ever needed, it would be installed under the road, not the sidewalk, and therefore does not justify postponing the current project.

It has come to my attention that the Ravenna St. to Stow Rd. sidewalks are in danger of being delayed until a possible future development has been completed. I urge you to keep the project on the current timeline and design and move forward with the current bid process.

My family has been looking forward to safely walking along our street to go to Colony Park and downtown Hudson instead of having to trample through our neighbors lawns to avoid the cars that frequently drive too quickly on our street as they travel from 91 to Stow Rd. As my three children are now all riding bikes, it has become even more scary to go the short distance to the sidewalks that begin at the Colony Park trail entrance. This is especially dangerous in the evening as there are no street lights.

Many of our neighbors also take the same risks walking on the street with their families and dogs because there is no sidewalk to safely travel from their homes to the nearby parks, Gloria Dei for church or preschool, and to the many events downtown. The sidewalk design is complete and contractors are already bidding for the job. Cancelling or postponing now would require a residesign and rebid and could delay the sidewalks for several years for a development that has not even been approved yet.

Additionally, the City Manager has stated the development will not be impacted by the potential development. If a waterline is required in the future, it would be placed under the road and would not interfere with the already planned sidewalk and if the developers damage the sidewalk, they would be responsible for repair costs, not the city.

Please consider this information as you consider this important issue for residents on Ravenna St. and the rest of the community that will benefit from using these sidewalks to safely travel around town.
