I wanted to voice my concerns about the process initiated last night at City Council regarding the suspension of our city manager. I do not currently have an opinion about her fitness for remaining in her job, but the speed this is moving is alarming. That this resolution was brought up last evening and is set to be discussed less than 24 hours later, at a time of day where many citizens are unable or unlikely to attend on short notice, raises serious concerns regarding the transparency of this process. I understand there are clear rules to follow in this situation, but moving to initiate that process in this manner suggests that Council does not want active community participation in this process. The urgency of moving on this so quickly after the introduction of the resolution is unclear. Our mayor has made clear his dissatisfaction with the city manager for some time, and proceeding in this manner has the effect of looking underhanded, if not the actual intent. The precedent of proceeding like this without an open request to the community for input is worrisome and hopefully not indicative of how the new Council will be conducting itself on matters concerning our entire community. I call on City Council to proceed in a transparent and thoughtful manner regarding this issue.
