1. Call to Order

Mayor Shubert called to order the meeting of Hudson City Council at 6:31 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Executive Session

A motion was made by Mr. Wooldredge, seconded by Mr. Foster, to enter into executive session to consider a personnel matter concerning the appointment of public officials and to interview applicants for the City's Architectural & Historic Board of Review. Mayor Shubert recessed the meeting at 6:32 p.m. after the motion carried unanimously.

Mrs. Bigham and Mr. DeSaussure entered the meeting at 6:35 p.m.

Mayor Shubert reconvened the regular meeting at 7:30 p.m.

5. Approval of the Minutes

6. Public Comments

Mrs. Slagle read correspondence from the following residents into the record (letters and emails attached to record copy of these minutes):

- Mrs. Carol O'Connell, President of League of Women Voters Hudson, expressed concern about changing Chapter 226 of the City's Administrative Code regarding campaign finance, as discussed at the Council workshop on March 23, 2021.
- Mr. and Mrs. Robert Krisch, 5971 Eastham Way, voiced concerns about proposed amendments to the District 7 Overlay and asked that if the City approves the amendments, that adding sidewalks and street lighting in the surrounding neighborhoods be considered.
- Mr. Jim Puflea, 5979 Brewster Drive, expressed support for tennis and pickleball courts, but he voiced concerns about noise, maintenance, and sanitation regarding a proposed dog park.
- Mr. Fred Innamorato, 27 Steepleview Drive, suggested the former Youth Development Center property owned by the City be turned into a nature preserve or active use park.
- Ms. Kathleen Battaglia, 1648 Groton Drive, suggested that the only portion of the 1927 school building worth saving is the auditorium, stating that City funds should not be used to purchase the building and that Hudson taxpayers should not be expected to fund the remediation or maintenance of it.
- Mr. and Mrs. Guy Wylie, 112 Parmelee Drive, asked a number of questions concerning the proposed dog park, involving its supporters, survey results, use of park finding, maintenance costs, and support from adjacent residents.

7. Correspondence and Council Comments

Mr. Foster provided an update regarding the special Park Board meeting held on April 19th. The meeting was well-attended, and much public input was received. He said that Board members were concerned about opposition to the proposed dog park, and they postponed this matter for further consideration at the May 17th Park Board meeting.

Mr. Sutton announced that he will host a Ward 3 Open Forum at 7 p.m. on June 7th at Hudson Springs Park, and he urged interested residents to attend. He also suggested that Council pass a resolution supporting a proposed rails to trails project (Veterans Trail) along the inactive Metro RTA Akron Secondary Rail Line, and he noted TASCforce's continued interest in this project. Council will consider such action at a future workshop.

Ms. Schlademan also commented regarding the special Park Board meeting, and she asked that the Police Department monitor speeding on Stoney Hill Drive and Ogilby Drive.

8. Report of Manager

Ms. Howington reported on the following:

- She encouraged citizens to speak in-person (or virtually) during Public Comments at regular City Council meetings. She asked those interested to register online, as seating is limited.
- In recognition of Earth Day and in response to citizen requests, the City has coordinated a recycling event on Saturday, April 24th on Owen Brown Street, at which e-waste will be collected. If successful, the City will consider scheduling such an event annually.
- With COVID regulations for sanitation and cleaning of bathrooms, local establishments will not be able to handle the number of individuals who want to use their bathrooms during downtown events. The City is considering adding portable restrooms in the downtown area this summer. She asked for Council's guidance at a future workshop regarding a more permanent solution.
