

AN ORDINANCE AMENDING VARIOUS SECTIONS OF THE FIRE PREVENTION CODE, PART 16 OF THE CITY'S CODIFIED ORDINANCES, AND ADOPTING THE MOST CURRENT EDITIONS OF THE OHIO FIRE CODE AND THE INTERNATIONAL FIRE CODE

WHEREAS, this Council desires to amend the Fire Prevention Code to update references to current versions of certain codes and standards issued by the State of Ohio and its agencies and to reflect current practices and the organization of City departments.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1. Sections 1610.01, 1610.04(a), and 1640.01 of the Fire Prevention Code are amended to read as follows:

“1610.01 ~~2011~~ MOST CURRENT EDITIONS ADOPTED.

(a) Pursuant to Ohio R.C. 731.231, there is hereby adopted by the Municipality the Ohio Fire Code (OFC), and its appendices, as adopted by the Ohio Department of Commerce, Division of State Fire Marshal, being particularly the ~~2011~~ most current edition thereof, with amendments, as published in Division 1301:7 of the Ohio Administrative Code (OAC).

(b) The International Fire Code, ~~2011~~ most current edition, as amended by Chapters 1301:7-1 to 1301:7-7 of the Ohio Administrative Code and as published by the International Code Council, Inc. is incorporated herein as fully as if set out at length.

(c) All future amendments to the Ohio Fire Code are incorporated by reference into the Fire Prevention Code of the Municipality without further action by the Municipal Council.

1610.04 ENFORCEMENT; RESPONSIBILITIES OF MUNICIPAL FIRE SAFETY INSPECTOR.

(a) No person shall serve as a Municipal Fire Safety Inspector unless ~~he~~ that person has received a certificate issued ~~by the Ohio Superintendent of Public Safety~~ under former Ohio R.C. 3303.07 or Ohio R.C. 4765.55 evidencing ~~his~~ that person's satisfactory completion of a fire safety inspector training program.

1640.01 ADOPTION OF ~~2006~~ MOST CURRENT EDITION OF
NFPA 1123 CODE FOR FIREWORKS DISPLAY.

Pursuant to Ohio R.C. 731.231, there is hereby adopted by and for the ~~City~~
Municipality the ~~2006~~ most current edition of the National Fire Protection
Association 1123 Code for Fireworks Display as referenced by the most current
edition of the Ohio Fire Code, a copy of which is attached to original Ordinance
~~06-17, passed February 1, 2006, as Exhibit A, and incorporated herein by~~
~~reference.~~

Section 2. Sections 1610.01, 1610.04(a), and 1640.01 of the Fire Prevention Code, as
they existed prior to the effective date of this Ordinance are hereby repealed.

Section 3. It is found and determined that all formal actions of this Council concerning
and relating to the adoption of this Ordinance were adopted in an open meeting of this Council,
and that all deliberations of this Council and any of its committees that resulted in such formal
action were in meetings open to the public in compliance with all legal requirements, including
Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance shall take effect and be in force from and after the earliest
period allowed by law.
