

Village Engineer, David Krock of Krock-Esser Engineering [KEE], will require a road permit for any work for the waterline on the Village right-of-way. You will also need approval from the City of Cleveland, Department of Water, as well as the City of Hudson Engineer [Hudson Water Department] in order to complete the project.
