1. Call to Order

President of Council Foster called to order the workshop of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Correspondence and Council Comments

Mr. Foster provided an update on the Planning Commission meeting that was held on September 12, 2022. He further stated that appointments to the Comprehensive Plan Steering Committee will be made next week.

3. Discussion Items

A. <u>22-0080</u> Sister City Guidelines

Brief Description: The project is being sponsored and managed by the Ohio Department of Transportation (ODOT). As part of the project, the City has requested widening of the sidewalk along the west side of SR 91 to better accommodate a future multi-purpose path along this section of roadway.
