1. Call to Order

President of Council Wooldredge called to order the workshop of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Correspondence and Council Comments

Mr. Sutton provided an update on the Tree Commission meeting that was held on April 22, 2021. He further thanked Mr. Forst's Cub Scout Pack 3321 for its donation of 100 tree saplings that will be planted along the tree lawn at a Hudson Park. Council requested that a thank you note be sent on their behalf to Mr. Forst and his Cub Scout Pack for their donation.

Mr. Foster stated that he has heard from numerous residents within The Reserve at River Oaks regarding the recent lowering of the storm water ponds within their development, and requested that Mr. Kosco attend a meeting April 28, 2021 with him and the residents.

Ms. Schlademan stated that she recently learned about an accident that involved a boy at SR 303 and Library Street. She requested that staff look into installing "No Turn on Red" signs at various intersections for the safety of pedestrians and bicycles. The intersections included; Library Street and SR 303, SR 91 and Prospect

Street, Atterbury Blvd and SR 303, and SR 303 and N. Hayden. Mr. Sheridan stated that he will report back to Council at the meeting on May 4, 2021.

Mrs. Kowalski stated that she has heard from residents regarding concern over the Prairie State Energy Campus, and they have questioned if the City has a plan of action if something were to happen. Ms. Howington stated that staff will be bringing forward the rate study in June, and this topic can be discussed at that time.

Mr. Bigham thanked Mr. Fran Lecklikner for his efforts in sustainability. She stated that Mr. Lecklikner has refurbished and donated over 100 mechanical items to various organizations and the community over the years.

Mr. Wooldredge reminded citizens that current vacancies exist on the Tree Commission and Park Board, with applications due on May 20, 2021. He encouraged interested citizens to apply.

3. Discussion Items

- A. [21-0032](#) **2021 Land Development Code Update**
Brief Description: City Staff has updated and expanded the preliminary amendment list from March of 2020 to continue some commercial focus items but also to incorporate some proposed amendments focused on efficiency and addressing noted requests from Council and residents.

Mr. Hannan reviewed and there was discussion on the proposed Land Development Code updates that included the following sections: sign code related to shopping centers, drive-thru restaurants, streamlining of permit review process, accessory dwelling units, narrow and deep residential lots, swing sets and playhouses, window placement on accessory structures, skirting requirements for decks, fence material, glass block windows, siding installation, garage placement, minor administrative items, and Zoning District/Map Amendments. Mr. Hannan stated that staff will compile a memo consisting of a summary of the items that had general consensus. Those items will come before Council for a first reading and referral to Planning Commission on June 1, 2021. He further stated that staff will compile a second list that will include topics for future and further study.

This matter was discussed.
