Mayor Currin called to order the public hearing at 7:39 p.m. Mr. Richardson provided an overview of this Ordinance and the recommendations provided by the Interim City Manager

and Planning Commission. He identified data presented in the Annual Review Report that was current at the time of publication and explained that it has since changed. Mr. Basil clarified that allocations are awarded twice annually. There were no other comments. Mayor Currin closed the public hearing at 7:41 p.m.

#### 8. Correspondence and Council Comments

Mr. Wooldredge said that he recently participated in an economic development familiarization tour, and he commented that the presentations and tour were excellent. He and Mayor Currin thanked Mr. Wiedie for coordinating this event for the City's regional economic development partners.

Mr. Kelemen said that the Environmental Awareness Committee has received a grant from ReWorks of Summit County for trash/recycling receptacles, which will be installed in City parks. Mayor Currin commented that there is also a need for cigarette butt receptacles in the Parks and elsewhere in the City. Mr. Kelemen acknowledged this need but noted that the grant funding was specific to recycling.

Mr. Kelemen thanked Mayor Currin for recognizing the Tree Commission in the June 2014 issue of Hudson Life Magazine. He noted that there will not be a Tree Commission meeting this month.

Dr. Williams said that the Cable Television Advisory Committee recently discussed concerns regarding the Time Warner acquisition and its effects on HCTV. He said that the Committee will continue to monitor this matter.

Mayor Currin reminded everyone that May is 'Lemonade Day' Month, and he encouraged citizens to purchase lemonade at local stands in support of student efforts.

### 9. Appointments

Mr. DeSaussure said that the City is currently accepting applications for the Architectural & Historic Board of Review and the Park Board, and the deadline for applications is June 13, 2014.
