

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A
CONTRACT WITH THE DAVEY TREE EXPERT COMPANY FOR TREE
TRIMMING AND MAINTENANCE SERVICES.

WHEREAS, competitive bids were solicited for tree trimming services for a two-year time period from January 1, 2020, through December 31, 2021, with an option for a two-year renewal at the end of the two-year term; and

WHEREAS, The Davey Tree Expert Company, Kent, Ohio, was the lowest and best bidder.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. The City Manager is authorized to enter into a two (2)-year contract with The Davey Tree Expert Company, Kent, Ohio, for a term to begin January 1, 2020, and to run through December 31, 2021, at the unit pricing specified in Exhibit "A" attached hereto, for a contract term of two (2) years and subject to appropriations by Council.

Section 2. The City Manager is further authorized to exercise an option to renew said contract for up to two (2) additional years dependent upon pricing and quality of service and subject to appropriations for this renewal contract by Council.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Resolution will take effect and be in force from and after the earliest period allowed by law.
