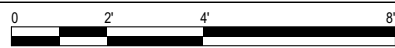
1 FRONT OF HOUSE ELEVATION (NORTH)

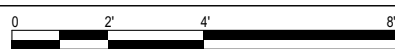
2 REAR OF HOUSE ELEVATION

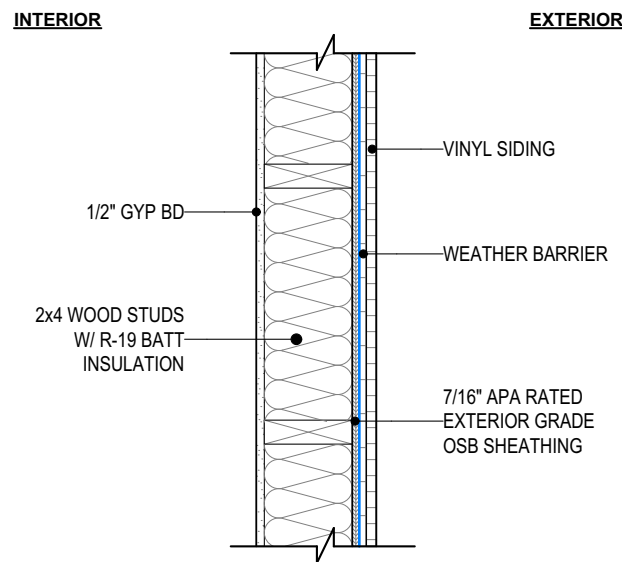

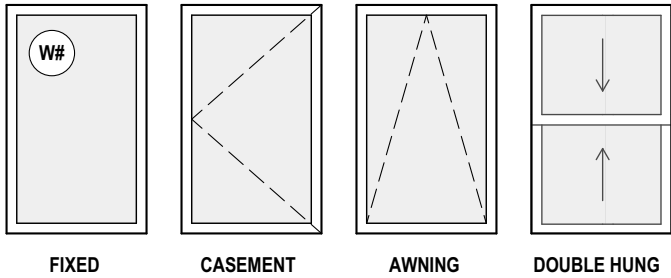
