

A RESOLUTION APPROVING THE APPLICATION FOR PLACEMENT OF LAND IN A CURRENT AGRICULTURAL USE DISTRICT FOR PURPOSES OF O.R.C. 929.02 FOR JOSEPH H. STRIBRNY, 5578 SHAWNEE TRAIL AND 896 TEREX ROAD, HUDSON, OHIO.

WHEREAS, this Council has received an application on January 17, 2019, for placement of land in a current agricultural use district for purposes of O.R.C. 929.02 for Joseph H. Stribrny, 5578 Shawnee Trail and 896 Terex Road, Hudson, Ohio, being Permanent Parcel Nos. 30-09602, 30-02989, 30-02990, 30-09598, 30-09599, 30-06766, 30-09600, and 30-09601, consisting of approximately 105.0474 acres; and,

WHEREAS, on February 5, 2019, this Council conducted a public hearing on this matter.

NOW, THEREFORE, Be It Resolved by the Council of the City of Hudson, Summit County, State of Ohio:

Section 1: That the application of Joseph H. Stribrny, 5578 Shawnee Trail and 896 Terex Road, Hudson, Ohio, to place approximately 105.0474 acres of land (Permanent Parcel Nos. 30-09602, 30-02989, 30-02990, 30-09598, 30-09599, 30-06766, 30-09600, and 30-09601) in a current agricultural use district for purposes of O.R.C. 929.02 be, and the same hereby is, approved.

Section 2: That the approval granted in Section 1 of this Resolution does not affect the applicant's obligation to comply with the provisions of the City's Land Development Code and other applicable City Ordinances.

Section 3: That the Clerk shall notify the Summit County Fiscal Office of City Council's decision herein and shall provide a copy of this Resolution to the Fiscal Office.

Section 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5: That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
