- 2. Building a recreation center as part of the Downtown Development Project Phase II would necessitate an increase in property taxes for the building, maintenance, and upkeep of the center. The amount of the increase is dependent on the type of center, as well as the amenities at the center. In addition, the total increase to your property taxes is based on the total value of your property.

So, for example, if you agreed to pay approximately \$50 more per \$100,000 of your property value and your property was valued at \$380,000 you can calculate the total increase to your property taxes by multiplying 50×3.8 , which amounts to an additional \$190 per year.

Knowing the impact on your property taxes, how much would you be willing to pay in additional property taxes to support the development of a recreation center?
