Mayor Currin urged citizens to support Lemonade Day activities during the month of May. He commented that Hudson is the epicenter of entrepreneurship, and this event is a wonderful teaching opportunity for Hudson's youth. Mr. Basil also encouraged residents to support Lemonade Day activities.

Mayor Currin read this Proclamation.

6. Public Comments

Mrs. Mary Hollenstine, 100 Blackberry Drive, urged Council to consider the lack of sidewalk connectivity along Prospect Street. She commented that there is a substantial section without sidewalks, and she expressed safety concerns and suggested that the City could, at a minimum, perform leveling and provide a crushed limestone path. She also spoke regarding a traffic study to determine the need for a left turn lane on Prospect Street for traffic heading north on State Route 91. She said that a considerable amount of traffic regularly cuts through on Morningsong Lane to avoid this intersection, and she felt a left-turn lane is warranted.

Mrs. Laura Jones, 63 York Drive, commented about the need to improve safety along North Hayden Parkway, as evidenced by a recent accident involving a young child. She asked that Council give priority to finding a solution and support funding for improvements to keep children safe on North Hayden Parkway. 7. Correspondence and Council Comments

Mr. Kelemen said that he appreciated the public comments regarding connectivity and expressed regret regarding the recent accident. He reminded parents, students, and motorists to review the safety tips available on the Schools' website and to be cautious. Mr. Basil agreed and encouraged motorists to drive slowly.

Mr. Basil said that the next Ward 2 Open Forum will be held at 7:30 p.m. on April 30, 2013, at the Barlow Community Center, and he encouraged interested residents to attend, noting that Mr. Bales and Mr. Sheridan will be available to provide information and answer questions.

Mr. Basil announced current vacancies on the Cable TV Advisory Committee and the Planning Commission and asked interested residents to apply.

Mr. Hanink agreed with comments regarding safety and connectivity. He said that Council is aware of the need for additional sidewalks along Prospect Street and will consider improvements.

Executive Summary: This legislation will retain Arcadis (consulting engineer) for the subject project in the base amount of \$137,500 plus \$2,500 in contingency, totaling \$140,000. The anticipated improvements which include: structural rehabilitation of the structures, improved channel armoring and improvement to the curbs, walks, aesthetic fascia and railing as needed. The City's ODOT approved process of Consultant Selection was used, which is a qualification based procedure. We received qualifications from two consultants: Arcadis and Michael Benza & Associates, Inc.
