

AN ORDINANCE AMENDING THE CITY'S TRAFFIC CODE IN SECTION 410.09, SCHEDULE IX, TO CHANGE TIME LIMITS FOR PUBLIC STREET PARKING IN CERTAIN AREAS OF THE CITY AND IN SECTION 410.10, SCHEDULE X, TO PROHIBIT PARKING AT ALL TIMES IN DESIGNATED PLACES; AND DECLARING AN EMERGENCY.

WHEREAS, Section 406.07 reserves to the Council the right to adopt various rules, regulations and proceedings in connection with traffic control; and

WHEREAS, after discussions with stakeholder groups, the City administration has recommended that the time limits for public street parking in certain areas of the City's Downtown be changed; and

WHEREAS, with completion of the North Main Street Improvement Project, there is currently no parking along the north side of Aurora Street between North Main Street and East Main Street.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. Section 410.09, Schedule IX, of the Traffic Code is hereby amended only as designated below:

“410.09 SCHEDULE IX – PARKING TIME LIMITED IN DESIGNATED PLACES.

Section 2. Those provisions of Section 410.09, Schedule IX, of the Codified Ordinances of the City that were in effect prior to the effective date of this Ordinance and that are in conflict with Section 1 above are hereby repealed and shall no longer have any effect to the extent that they are inconsistent with the amendments adopted in Section 1 of this Ordinance.

Section 3. Section 410.10, Schedule X, of the Traffic Code is hereby amended only as designated below:

“410.10 SCHEDULE X – PARKING PROHIBITED AT ALL TIMES IN DESIGNATED PLACES.

Following are the streets and portions of streets in the City on which parking is prohibited at all times:

Section 4. Those provisions of Section 410.10, Schedule X, of the Codified Ordinances of the City that were in effect prior to the effective date of this Ordinance and that are in conflict with Section 3 above are hereby repealed and shall no longer have any effect to the extent that they are inconsistent with the amendments adopted in Section 3 of this Ordinance.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Ordinance is an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents and motorists in the City and for the further reason that longer parking time limits are needed in order to better serve the residents, visitors, and businesses in the City's Downtown area; wherefore, this Ordinance shall take effect and be in force immediately upon its passage, provided it receives five (5) affirmative votes of members of Council, except that six (6) affirmative votes are required if all members are present; otherwise it shall be in full force and effect from and after the earliest period allowed by law.
