

A RESOLUTION AUTHORIZING THE CITY MANAGER'S DESIGNEE TO ACCEPT A FOUR THOUSAND DOLLAR DONATION FROM EMS OUTREACH OF HUDSON FOR THE PURCHASE AND INSTALLATION OF TWO AUTOMATIC EXTERNAL DEFIBRILLATORS WITH TEMPERATURE CONTROLLED OUTDOOR CABINETS.

WHEREAS, EMS Outreach of Hudson raises funds and provides programs to support health and safety initiatives within our community; and,

WHEREAS, EMS Outreach of Hudson approached the City about adding two outdoor automatic external defibrillators (AED) in the downtown area, which are the same as the units that were deployed through donations in the Hudson Parks; and,

WHEREAS, these two AED's in temperature-controlled boxes would be available year-round for use during special events and by patrons at surrounding businesses and restaurants in downtown Hudson, as locations on the First & Main Green and between the Clocktower and Gazebo Greens; and,

WHEREAS, EMS Outreach of Hudson raised \$4,000.00 for the purchase and installation of these defibrillators; and,

WHEREAS, the City of Hudson has been awarded a donation from EMS Outreach of Hudson in the amount of \$4,000.00 to fund the purchase of two automatic external defibrillators with temperature-controlled cabinets for installation on the downtown Greens; and,

WHEREAS, it is in the best interest of the City of Hudson and its residents to accept this donation; and,

WHEREAS, this Council wishes to accept the donation and express its sincere appreciation to the EMS Outreach of Hudson.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. The City of Hudson hereby authorizes the acceptance of the donation offered by EMS Outreach of Hudson, as determined by the Interim City Manager, and authorizes the City staff to install and put the units into use.

Section 2. The City of Hudson hereby expresses its appreciation for the donation, which will help protect and keep the residents of the community safer.

Section 3. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 4. This Council finds and determines that all formal actions of this Council and any of its committees concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council or its committees, and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, all in compliance with the law.

Section 5. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
