Special Council Workshop: 6:30 p.m.

1. Call to Order

President of Council Pro Tempore Williams called to order the special workshop of Hudson City Council at 6:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

Mrs. Bigham entered the special workshop at 6:35 p.m.

Others & Staff in Attendance: Mayor Basil; Ms. Howington, City Manager; Mr. Griffith, Management/Budget Director; Mr. Knoblauch, Assistant City Manager - Financial/Special Projects; Mr. Leiter, Production Assistant; Mr. Sheridan, Assistant City Manager - Professional Services; Mr. Tabak, Police Chief; and Mr. Varnes, Fire/EMS Chief.

2. Discussion Item

Dr. Williams announced that one additional budget workshop is planned on October 29, 2019, which will include discussion of an accelerated Road Program, Velocity Broadband, and a wrap-up.

A. [19-0104](#) City of Hudson 2020 - 2024 Five-Year Plan Review and 2020 Budget

Brief Description: This is the fourth of five scheduled meetings to review the City's 2020-2024 Five-Year Plan and 2020 budget. This meeting will focus on Police, Fire Fund, and EMS Fund.

Mr. Griffith and Chief Varnes reviewed the Fire and EMS Funds. Topics included combined funding through net income tax revenues, allocations and operational reporting within the separate Fire and EMS Funds, future capital needs, consideration of combining the two departments in the future, ambulance billing, and reserve funds.

Mr. Griffith and Chief Tabak reviewed the Police Fund. Discussion topics included: personnel and dispatch. Chief Tabak provided an update on negotiations with Bath concerning virtual dispatch operations and leasing dispatch equipment from AT&T. He said that this will allow participating agencies to maintain local dispatch center operations, and additional local governments may join. Mr. Griffith explained that compared to purchasing a new 9-1-1 system for \$266,000, the lease option would reduce expenses to approximately \$35,000 annually for the term of the lease. Other topics discussed included: dispatch statistics and contractual services.

This matter was discussed.

B. National Incident Management System (NIMS) Training for Elected Officials

Chief Varnes explained that NIMS training is required for federal, state, county, and local officials. He said City staff is nearly compliant with training requirements, but elected officials need to take the NIMS Awareness Training (IS-700). He noted that Federal Preparedness grants are based upon NIMS compliance, and he provided detailed information to elected officials on how to take the online training and obtain certification (hand-out attached to record copy of these minutes).

This matter was discussed.

3. Adjournment

There being no further discussion, Dr. Williams adjourned the special Council workshop meeting at 7:27 p.m.

Mrs. Slagle said that the October 1, 2019, meeting minutes have been corrected to record a second reading for Resolution No. 19-132, noting that this legislation will have its third reading on this evening's agenda.

Mrs. Michelle Dolciato, Mr. Gary Maher, and Mrs. Trish Flood-Davis accepted the Proclamation on behalf of The Hudson Players. Mr. Maher encouraged everyone to attend the upcoming plays at the Barlow Community Center.

Mayor Basil read this Proclamation in its entirety, recognizing and thanking The Hudson Players and proclaiming November 1, 2019, as The Hudson Players Day in Hudson.

9. Public Comments

Mr. Lou Verhas, 1701 Groton Drive, spoke regarding use of the community rooms at the new City Hall, and he asked City Council to consider opening the rooms for family gatherings and other catered events.

10. Correspondence and Council Comments

Mayor Basil thanked Chief Varnes and all personnel involved with the Fire Safety Open House this past weekend.

Following-up on the October 8, 2019, workshop discussion regarding use of the City Hall community rooms, Mr. Kelemen asked that the City research use of Community Learning Centers with the Schools. He also suggested that the City provide a link on the website for public rental spaces, and he noted that Ellsworth Meadows has a patio and a meeting room available for rental. Mayor Basil added that a covered picnic shelter is also available.

Mrs. Bigham reported the Planning Commission approved an addition for Seton Catholic School at their meeting on October 14, 2019. She also reported that the Hudson Baseball Association has requested improved

drainage for ball fields and has asked that Council consider funding. She suggested the City research improvement costs, and Mr. Hanink said that this work is currently underway.

11. Report of Manager

Ms. Howington said that the proposed 2020 Budget / Five-Year Plan is posted on the City's website.

Concerning Hudson Baseball Association's request, she said that staff is working with landscaping firms and will present a proposal to Council for safety measures and regrading of the infields, with improvements to be performed this year; and then after the 2020 season, the City plans to commence with underground drainage work.

A. National Incident Management System (NIMS) Training for Elected Officials

Chief Varnes reviewed this matter during the special workshop (see item 2B).

12. Discussion Item

A. [19-0108](#) Presentation: Energy Special Improvement District (ESID)

Brief Description: Chris Burnham, Development Finance Authority of Summit County (DFA), will present information and answer questions about the ESID Program. Passage of proposed Ordinance No. 19-147 would enable the City to become a participating political subdivision of the Akron-Summit County Energy Special Improvement District (ESID). As a result, businesses located within the City of Hudson will be able to have the financing costs of approved energy improvement projects be repaid through an assessment on the property.

Mr. Chris Burnham, President of the Development Finance Authority (DFA) of Summit County, spoke regarding Summit County's Energy Special Improvement District (ESID) and explained how this program has expanded within the County to benefit businesses and residents interested in investing in qualified energy improvements. He provided an overview of participating communities and business projects to date, and he discussed ESID financing tools available, wherein the DFA finances qualified projects, and amounts are assessed to property taxes (see materials attached to record copy of these minutes).

He encouraged City Council to consider legislation to authorize the ESID within Hudson for the County to perform a business project for an LED lighting upgrade at a Department of Sanitary Sewer Services station on Terex Road. Discussion followed. Mr. Burnham noted that if a subject property is sold, the loan (tax lean) is passed on to subsequent property owner(s). Other topics discussed included the Loan Loss Reserve Fund and the residential program, which is separate from the proposed business program. Mr. Burnham said there is no liability exposure to the City, the City may opt out if desired, and each participating community is represented on a Board that approves transactions.

This matter was presented and discussed. Ordinance No. 19-147 was given a first reading (see Legislation item 15E).

13. Appointments

Dr. Williams said that the City is accepting applications for the Environmental Awareness Committee through November 1, 2019, and Mayor Basil encouraged interested citizens to apply.

Brief Description: The bulk of the City’s current Land Development Code (“LDC”) was adopted in 1999 - just five years after the merger of Hudson Village and Hudson Township. While the original 1999 LDC has been amended over the years, a full update has not been undertaken since the LDC’s original adoption. In April of 2017,

with a recently adopted Comprehensive Plan in hand (the 2015 Comprehensive Plan - passed on January 19, 2016 by Hudson City Council), the City began a year-long process to update the LDC. The draft amendments represent the Step I administrative-focused amendments. Future updates for Step II - Commercial and Business Land Uses and Step III - Residential Land Uses would be considered at a later date as part of a separate request from City Council.
