ARTICLES OF INCORPORATION

OF

The undersigned, all of whom are citizens of the United States, desiring to form a corporation not for profit under Title XVII, Chapters 1724 and 1702, of the Revised Code of Ohio, do hereby certify:

FIRST: The name of the corporation shall be Hudson Community Improvement Corporation.

SECOND: The place in this State where the principal office of the corporation is to be located is the Village of Hudson, Ohio, Summit Co.

THIRD: The sole purpose for which the corporation is formed, is to advance, encourage, and promote the industrial, economic, commercial, and civic development of the Village of Hudson, by acting as the designated agency of the Village of Hudson, for the industrial, commercial, distribution, and research development in such political subdivision in accordance with Section 1724.10, Revised Code.

FOURTH: The names and post office addresses of the initial trustees of the corporation are as follows:

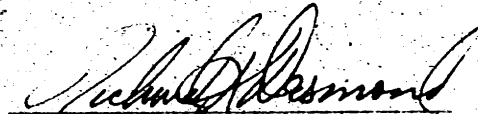

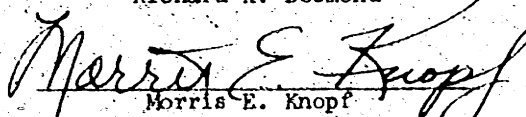
FIFTH: All of the funds and assets of the corporation, together with the net earnings thereof and income realized thereon, shall be exclusively devoted to the purpose hereinabove expressed, and no part of its net earnings shall inure to the benefit of any private member, shareholder, trustee or individual.

SIXTH: In carrying out its purpose and in exercising the powers granted to it by law, the corporation shall be subject to the following restrictions, namely, (i) no substantial part of its activities shall consist of carrying on propaganda, or otherwise attempting, to influence legislation, and (ii) it shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office.

SEVENTH: In the event of any voluntary or involuntary dissolution or liquidation of the corporation, or in the event of failure to reinstate these Articles after cancellation thereof, any remaining assets of the Corporation shall be paid over and distributed as determined by the trustees with the approval of the Court of Common Pleas of Summit County, to the Village of Hudson from which on the date of dissolution, liquidation or cancellation of the Articles of the Corporation there exists a designation of the corporation to act as agent pursuant to paragraph THIRD of these Articles, to be used exclusively for designated civic projects or public charitable purposes.
