## **Introduction**

On June 7, 2020, Hudson City Council formally adopted Resolution 20-69 creating a Designated Outdoor Refreshment Area (DORA) in accordance with Ohio Revised Code (ORC) 4301.82. The DORA allows restaurant patrons to legally walk through an established contiguous area with an alcoholic beverage served by a properly licensed facility. The boundaries of the DORA include 32.5 acres with 11 qualified permit holders. Within the original application, the City identified the following areas to ensure public health and safety:

- Law Enforcement Duties
- Fire/EMS Responsibilities
- Required Cups
- Special Event Requirements
- Outdoor Dining and/or Events on Properties in the DORA
- Signage
- Sanitation
- Hours of Operation

In addition to components of public health and safety, the specific boundaries of the area, including street addresses and nature of the businesses within the DORA were also identified.

As a requirement of ORC 4301.82, five years after the date of creation of an outdoor refreshment area, the legislative authority of the municipality that created the DORA shall review the operation of the area, by ordinance or resolution, and either approve the continued operation of the area or dissolve it. Prior to adopting the ordinance or resolution, the legislative authority shall give notice of its proposed action by publication in one newspaper of general circulation of the municipal corporation as provided in section 7.16 of the Revised Code. A five-year review shall be conducted in the same manner as (I)(1) of this section.

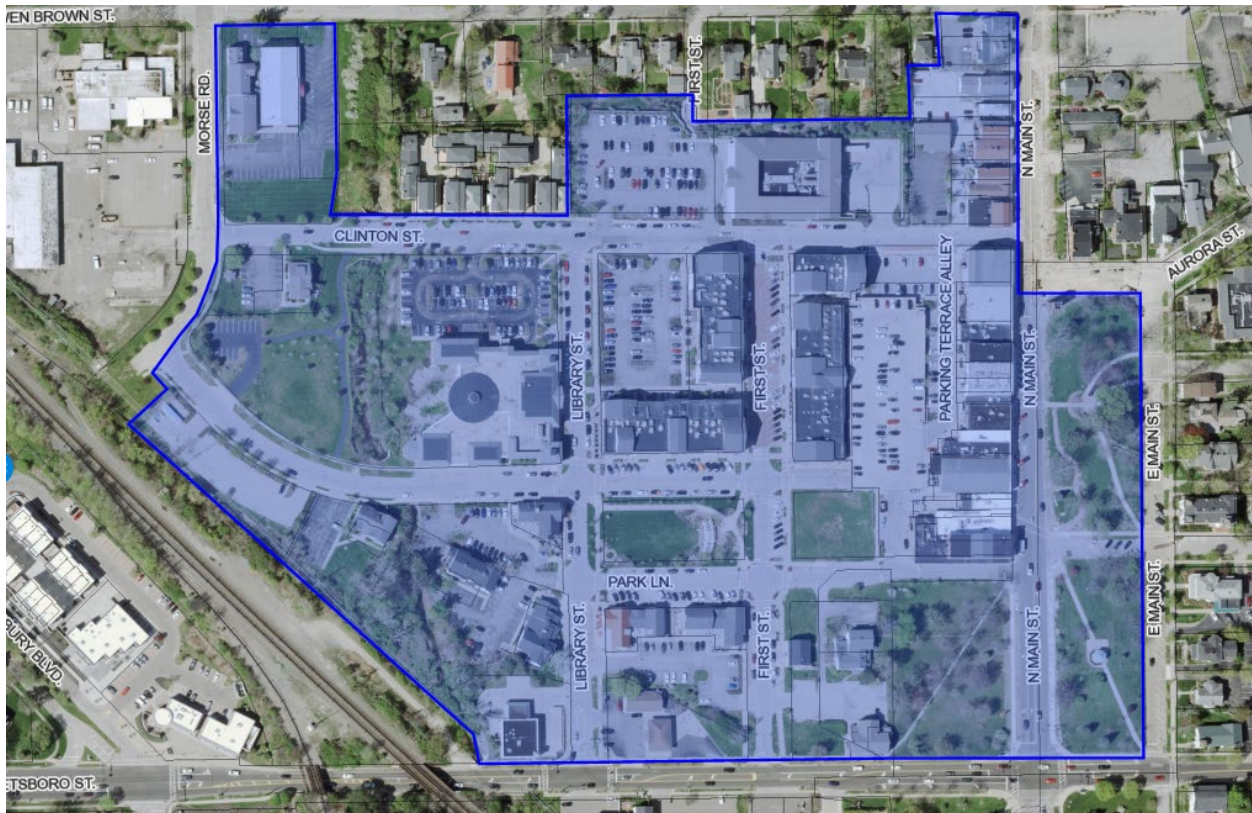
This application provides review of the originally established DORA and any recommendations or changes for continued operation to be reviewed by City Council.

## Section 1: Boundaries of the Proposed Outdoor Refreshment Area

The 2020 DORA boundaries were established in accordance with Ohio Revised Code (ORC) 4301.82 (B)(1)(b) stating a maximum area must not exceed one hundred fifty contiguous acres if the municipal corporation or township has a population of thirty-five thousand or less. The reported 2010 decennial census of 22,262 was used for this calculation with a 31.8-acre boundary. In accordance with ORC 4301.82(F)(1)(a), the boundaries of the DORA are depicted in blue below.



Since the DORA's conception, ORC Chapter 4301 was updated on March 23, 2022 to allow municipalities with a population of less than fifty thousand up to three hundred twenty contiguous acres and three outdoor refreshment areas with at least two qualified permit holders. The 2020 Census data for Hudson, Ohio increased to 23,111.

***Following discussion with Hudson Police and Fire Departments, staff recommends maintenance of the current DORA boundaries without expansion with the following considerations:***

- ***Expansion of DORA would require additional pedestrian crossings over major roadways/intersections at St. Rte. 303/Streetsboro Street; and***

- *The current DORA has well defined boundaries and is easily managed by public safety officials without major incidents.*

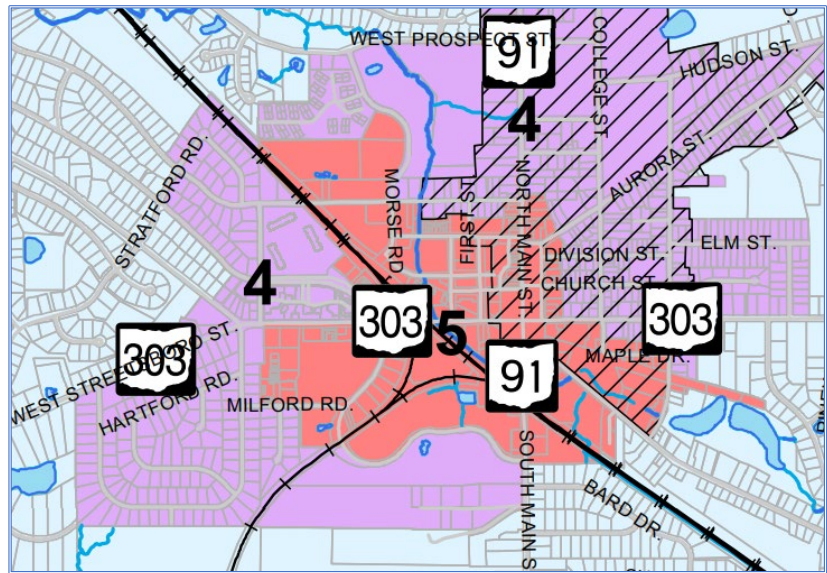

## Section 4: Evidence that the uses of land within the proposed outdoor refreshment area are in accord with the master zoning plan or map of the municipal corporation

The uses of the land within the DORA are in accord with the City of Hudson Zoning Map and the 2024 Comprehensive Plan.

City of Hudson Zoning Map: The DORA Boundary is located within Zoning District 5: Village Core District. The district is intended to preserve and protect the Village Core, which is the historical and commercial center of the City of Hudson. Establishment of the DORA is consistent with and will not conflict with the current zoning.



### 2024 Comprehensive Plan:

The implementation chapter of the 2024 Comprehensive Plan established Objective 1.4.1, which states, “Expand the DORA (Designated Outdoor Refreshment Area) boundary to include additional downtown properties within the state allowances.” On the Future Land Use Map, the DORA falls within the ‘Downtown’ district that is shown in purple on the map. The green areas are City-owned public green spaces near the center of the Downtown district. ‘Downtown’ is described as an area for compact and pedestrian-scale retail, services, mixed-use, and public uses. Expansion of the DORA is explicitly supported by the current Comprehensive Plan and aligns with the future land use map.



## Section 5: Ensuring public health and safety within the DORA

In accordance with ORC 4301.82(F)(1), the requirements for ensuring public health and safety have been outlined and reviewed below.

### Law Enforcement Duties:

The City of Hudson Police provides Law Enforcement services within the DORA. The main police station is located within 0.4 mile from the district boundary. The on-duty supervisor ensures that appropriate attention is provided to the DORA during hours of operation and Temporary Special Events. Hudson Police Department has been able to meet the needs of the DORA with adequate staffing over the past five years. Events attracting large crowds at times have required additional patrol or assigned officers within the DORA. The use of foot patrol, bicycle patrol, as well as special operations bureau has been considered as alternate methods of patrolling the DORA.

As an added precaution, Hudson Police Department was included within the Temporary Special Events workflow to determine if events attracting large crowds require additional police coverage.

***The Police Chief reported in December 2024 there have not been any incidents in Downtown Hudson related to the DORA and recommends no operational changes for the police department with continued operation. The existing DORA footprint can be maintained with current staff through safety services.***

### Fire/EMS Responsibilities:

The City of Hudson provides fire, rescue, and EMS services within the DORA. The primary fire/Ems station is located 0.4 miles from the district boundary. Hudson Fire and EMS have been able to provide services to adequately meet the needs of the DORA District on a daily basis.

For special events within the DORA drawing large attendance, the Fire/EMS Chief may stage additional personnel and/or equipment in a location within or near the DORA to allow for an immediate response.

***The Fire Chief reported in December 2024 there have not been any incidents in Downtown Hudson related to the DORA and recommends no operational changes for fire/EMS with continued operation.***

### Required Cups:

To ensure only permitted establishments within the DORA sell alcohol to patrons, beverages must be served in compostable or recycled plastic material cups with a uniform Hudson DORA label. No other containers shall be permitted.

### Special Events:

The City of Hudson requires that each special event receive a permit with review by applicable city departments. Event organizers may be required to pay for special duty officers or overtime for public service or safety workers, if determined by the City of Hudson, to ensure adequate health and public safety requirements. The City of Hudson special event rules, procedures, and regulations remain in effect within the DORA District.

### Outdoor dining and/or events on property within the DORA:

Permit holders that sell alcoholic beverages as part of an outdoor dining area in City of Hudson's Right of Way (adjacent to the establishment), must obtain a license agreement from the City of Hudson. The permit holder may not sell alcohol outside their permit area. These policies require the license holder to submit a physical layout of the tables, chairs, and other facilities. The license and permit review ensure there will be adequate pedestrian pathways and ingress/egress for emergency services. Failure to comply with the agreement can result in revocation.

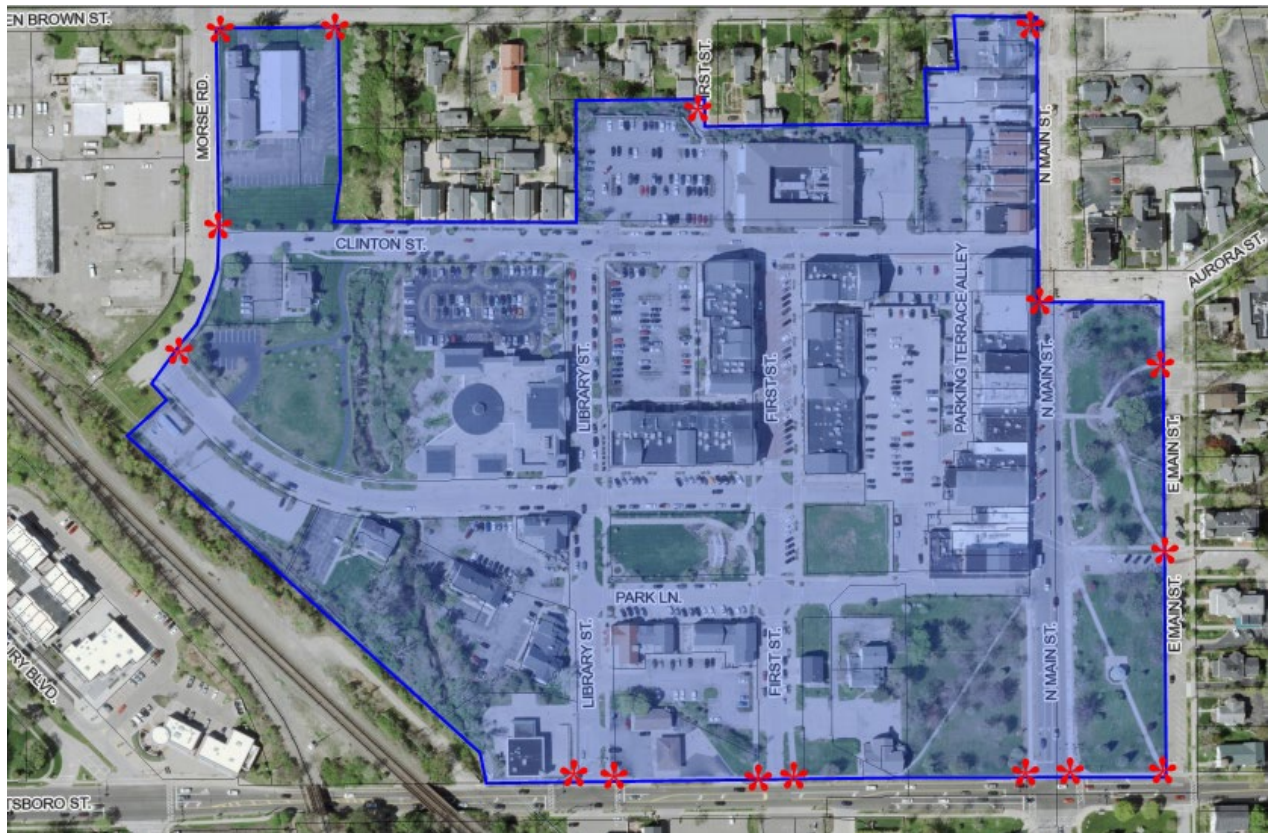
Restaurants without a liquor permit and any other establishment within the DORA may allow patrons with DORA cups to enter their establishment if permitted by the owner.



Signage:

The City of Hudson has 16 boundary signs installed throughout the DORA as indicated on the map below. Patron use will be monitored on an ongoing basis with additional signage installed where needed. Portable signage may be used as needed for special events.

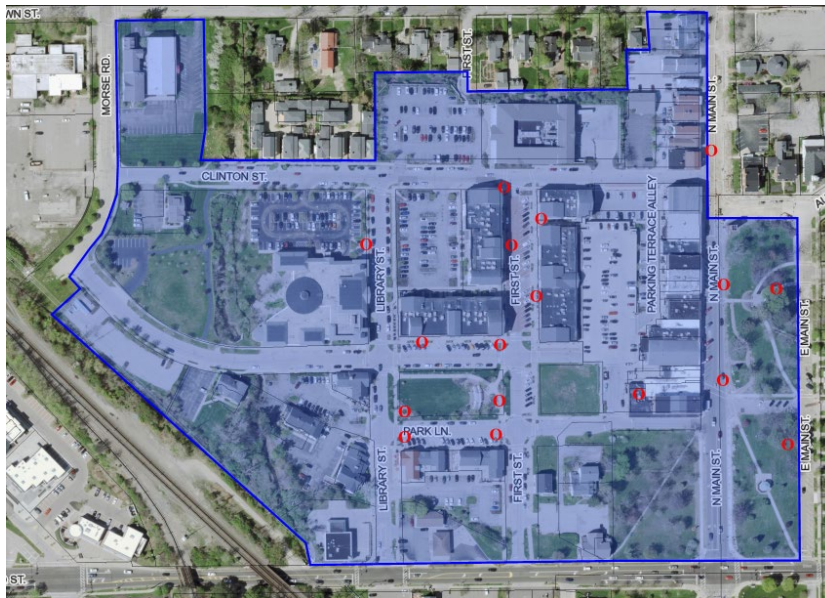
*Sign locations were reviewed in December 2024 and public works recommends no changes in the five-year review.*



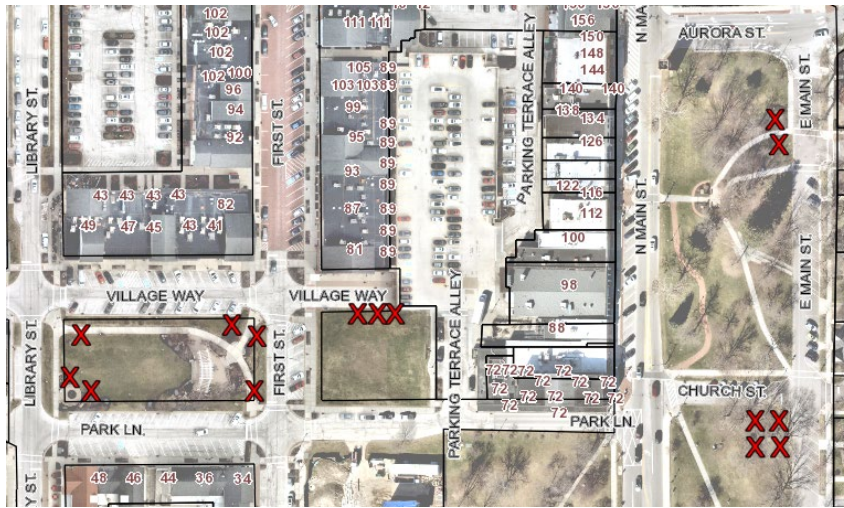
**Sanitation Plan:**

There are 17 permanent waste and recycling containers located within the DORA. To meet the sanitation demand of the DORA since 2020, an additional 15 trash receptacles were added. From Memorial Day through Labor Day, all receptacles are emptied Monday, Wednesday, and Friday. Depending on special events, an additional Saturday night or Sunday morning clean-up is added. Services are provided by City staff, AA Sanitation, and the contracted landscaping company. Outside of special event season, trash is only removed on Monday.

Since the establishment of the DORA, hours of operation were updated by Resolution 20-100 and Resolution 20-169 to extend hours. In accordance with ORC 4301.82(f)(1)(c) the hours of operation are recommended to continue as:

- Monday – 12:00 pm to 10:00 pm
- Tuesday – 12:00 pm to 10:00 pm
- Wednesday – 12:00 pm to 10:00 pm
- Thursday – 12:00 pm to 10:00 pm
- Friday – 12:00 pm to 10:00 pm
- Saturday – 10:00 am to 10:00 pm
- Sunday – 10:00 am to 10:00 pm
