1. Call to Order

President of Council Wooldredge called to order the workshop of Hudson City Council at 6:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Executive Session

A motion was made by Mr. Sutton, seconded by Mrs. Kowalski, to enter into executive session to consider a personnel matter concerning the appointment of public officials and to interview applicants for the City's Park Board and Tree Commission. Mr. Wooldredge recessed the workshop at 6:31 p.m. after the motion was approved by voice-vote.

Mrs. Bigham entered the meeting at 6:35 p.m.

Mr. Wooldredge paused the workshop at 7:15 p.m and reconvened it at 7:30 p.m. for Council's regular order of business.

3. Correspondence and Council Comments

Mr. Sutton provided an update on his Open Forum, held on June 7, 2021. Topics included proposed townhomes, proposed dog park, connectivity, construction on Main Street, and stormwater issues. He asked for an executive session at the next meeting for Council to discuss potential property acquisition to alleviate stormwater issues in Ward 3.

Mrs. Bigham read a letter from Mr. Chris Banweg encouraging an end to the hatred and division in Hudson. She also read two other letters from Mr. Jeff Keil and Celeste Fland in opposition to spending taxpayer dollars on a diversity, equity, and inclusion initiative or on critical race theory.

Ms. Schlademan provided an update on the Environmental Awareness Committee meeting, held on June 7, 2021. Topics included a recycling education grant and a Green on the Green event to be held on September 4, 2021.

Mayor Shubert provided an update on a meeting he attended on June 7, 2021, with Governor DeWine and 9 other Mayors; topics discussed included: broadband expansion, police reform, sewer and water accessibility, income tax revenue transfers to cities of residence relating to individuals working from home if different from their employment city, and the Dolly Parton Imagination Library Program. He further provided an update on a meeting he had with the Ohio Department of the American Legion regarding Hudson Post 464.

4. Discussion Items

A. <u>21-0047</u> Presentation of the AMP organization and the Prairie State Energy Campus

<u>Brief Description:</u> American Municipal Power representatives will present a brief history of the AMP organization and its relationship with the City of Hudson. The AMP staff will also present information regarding the Prairie State Energy Campus.

Mr. Comeriato introduced representatives in attendance from American Municipal Power, which included Pam Sullivan, Rachel Gerrick, Scott Kiesewetter, and Adam Ward. They presented a brief history of the AMP organization and its relationship with the City of Hudson. AMP staff provided information regarding the Prairie State Energy Campus. Council asked questions about the future of Prairie State and expressed its concerns about the outstanding debt liability that the City would hold should the plant be shut down prior to the term of the debt. Council asked staff to come back with strategies for what to do should this occur, a possible exit strategy from Prairie State, and how it would impact the City financially.

This matter was discussed.
