OFFERED BY: MAYOR CURRIN

A RESOLUTION AUTHORIZING THE PURCHASE OF ENVIRONMENTAL SITE LIABILITY INSURANCE FOR THE 428-ACRE CITY PROPERTY ON HINES HILL ROAD; AND DECLARING AN EMERGENCY.

WHEREAS, the City is required by the Intergovernmental Agreement (Lease) with the Metro Parks Serving Summit County and the Trust Agreement with the County of Summit to provide environmental liability insurance for the 428-acre former Youth Development Center property in Hudson which is owned in trust by the County of Summit for the benefit for the City of Hudson; and

WHEREAS, the City has obtained quotations for the professional service of providing environmental site liability insurance as required by the aforesaid agreements and determine that the most reasonable terms are from the Chubb Custom Insurance Company for a five (5)-year term and a total premium of \$30,607.00.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. The City Manager is authorized and directed to purchase a policy of environmental site liability insurance as proposed by the Chubb Custom Insurance Company for a term of five (5) years at a premium of \$30,607.00 and the Director of Finance is authorized and directed to appropriate to a proper account the funds necessary for this premium under the general terms and conditions as set forth in the attached "Advice of Insurance", Exhibit A.

Section 2. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health safety and welfare and for the further reason that it is necessary to have no gap in insurance coverage at the subject property between the current coverage and this renewal policy coverage; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five members of Council, except that six affirmative votes shall be required if all members are present; otherwise, it shall be in full force and effect from and after the earliest period allowed by law.
