Hudson Senior Network (HSN) 5-Year Business Plan Goals

Introduction

The Hudson Senior Network (HSN) was organized as an advisory group in 2019. HSN incorporated as a 501c3 in 2021 to become a not-for-profit organization with the ability to apply for grant funds as well as to partner with other community organizations for the benefit of Hudson's growing senior citizen population. The Hudson Senior Citizens group was organized in 1967 and a short history is attached (Appendix A). Like the HSN, this group provides programs and a monthly lunch. Over the last few years, the HSN and the Hudson Senior Citizens group have shared activities and information together. Discussions have been ongoing about blending activities into a single source program providing educational information. We are happy to announce that on November 8, 2022, HSN and Hudson Senior Citizens Group have formally combined efforts to best serve the senior population in Hudson (Appendix B) and will be known as the Hudson Senior Citizens group activities within the expanded programming and communications of the HSN.

Today, our Business Plan Goals are respectfully presented to the Mayor, City Council Members, and the community at large. Why now? Hudson's over 65 population is growing. The 2010 US Census recorded 12% (Appendix C) of the City's overall population to be over 65. The senior population has grown to 18% per the 2020 US Census (Appendix D). The Summit County Public Health Vital Statistics report (source information obtained from the Ohio Development Services Agency, 2015-2019 American Community Survey, 5-year average), states the senior population is expected to increase to 22% by 2035 (Appendix E). Statistically, we are an aging community. Additionally, as the Comprehensive Plan update is expected to be completed by the end of 2023, it is important to have the senior population's needs and interests included in this community conversation.

HSN has, and currently offers, educational programming series on topics such as social security, Medicare, health issues, and safety. Social programs are important to seniors as many live alone and need social engagement. Some of the social programs provided include a night of big band music by the Hudson Community Band and a Holiday Luncheon with music in December. Additionally, during COVID, holiday drive-throughs provided holiday cheer to many who would otherwise have been alone. The lunch programs provided are especially beneficial for both social engagement as well as the educational component of the speakers that provide so much to our senior population. Communication and collaborative memberships will provide the ability to expand the dissemination of information that is important to seniors. For example, it would be imperative to have various sources of communication if a snowplow program were to be implemented. Social service needs are another example of how communication such as newsletters are an important element to inform our seniors about resources and programs available to and for them.

The following is a list of a few educational programs provided and expected to be provided:

- Downsizing
- Scams and Senior Safety
- Fire and Home Safety for Seniors
- Brain Health and Exercises
- Cybersecurity
- Lowering our Utility Bills
- Skin Care for Aging Skin and Skin Cancer Awareness
- Medicare Enrollment, Supplemental Plans and VA Benefits
- Fall Prevention (2023 and forward)
- Other health and safety topics to be determined (2023 and forward)

Our Business Plan Goals will benefit Hudson's senior population by providing an expansion of educational and social programming identified through questions included on senior citizen surveys conducted in 2019 (Appendix F) and 2021/2022 (Appendix G and H). Additionally, data was obtained via a SmartSheet form in September 2022 from seven surrounding communities on their senior programs (Appendix I).

Priorities

The following priorities provide information on each component of our 5-year Business Plan Goals and when the funding for each component is expected to be needed. Priorities were developed based on a 2019 and 2021/2022 senior survey, input from Hudson seniors, senior care agencies, hospitals, and other senior organizations. Additionally, as noted previously, data was obtained on senior programs provided by surrounding communities. A summary of the priority goals is included in Appendix J.

Efforts for funding considerations include, however, are not limited to:

- Grants
- Local Foundations
- Sponsors
- Fundraising
- Senior Organizations
- Other resources

We also respectfully request consideration from Mayor Anzevino, City Council Members, and the community at large to support our senior programming needs in the best interest of our growing senior population. The following is a narrative of business expansion goals in order of priority:

1. Expansion of senior programing \$31,000 for year 1

In kind contribution for box lunches is (\$7.00 - \$10.00 per lunch)

The HSN conducted surveys in 2019 and 2021/2022 and found that 71% and 90%, respectively, of respondents, felt programming for senior events such as lectures and educational presentations was a top priority. Currently an all-volunteer staff provides two educational programs per month with one having a free box lunch (sponsored by a community senior service facility). In summer of 2022, the HSN applied for a Community Development Block Grant (CDBG) for the purpose of doubling the senior programming events and the development/distribution of a newsletter. This grant is currently pending at the Summit County Community Development office with further details on approval expected in mid-November. Should the grant be approved, HSN would receive the grant monies which would fund program expansion for one year. Our Business Plan Goals would then be amended for funding needs to occur in year two and then as an ongoing need.

The CDBG grant application (Appendix K) submitted in July 2022 is attached for your reference. Most of the budget for this expansion of senior programming is for supplies (\$24,000). This expense priority covers items for the health and safety of seniors such as updated extension cords, fridge paks, fire extinguishers, etc. These items are listed in the grant application and the costs associated have been determined through an average of three estimates for each item.

Our Business Plan Goals combine all the community senior citizen initiatives and incorporates funding for retention and expansion of existing and expanded activities and programs. Expansion of programs includes trips paid 100% by attendees. HSN has partnered with the trip program offered at LifeCenter Plus and proposes to continue this partnership rather than add this type of transportation (and liability) to HSN.

2. Newsletter and Community Communications \$15,600 for year 1

The HSN has grown our programming through several organizations that provide services or information to senior citizens. This includes the senior service facilities, other not-for-profit community organizations, the Fire and EMS services (including the volunteers there), and the City website, to name a few. The senior citizens we are not reaching are those living on their own that do not participate in electronic communications. Printed and mailed newsletters also reach children of senior citizens that can then pass on program and educational information to their parents.

As our programming participation grows, there is a need to use conventional communications (i.e., a newsletter) to provide information and education to all Hudson seniors and their families. The CDBG application that is pending would provide funding to begin such a newsletter with publication and distribution of four

editions for one year. Once again, our 5-year Plan includes funding as an ongoing need. Costs for this priority include publication and mailing of four newsletters, estimated at \$15,600 for the first year (based on City's cost for their quarterly newsletter).

In reviewing Stow's Senior Newsletter, just one of the communities who provide a mailed newsletter to their seniors (Appendix M), they include advertising as a revenue generator. The HSN would do the same however, until we understand the quantity of revenue a quarterly newsletter would provide, we do not consider this an offset.

Potential advertising revenue from the following sources to be considered for the newsletter:

- Senior Care Facilities
- Hudson restaurants
- Hudson real estate agencies
- Home security companies
- Other agencies

3. Support Staff

\$15,000 for year 1

As the HSN services and programs expand, there is a need for part-time administrative support via HSN. This support would provide coordination of the newsletter, programming, responding to phone calls and emails, and coordination of volunteers. This support position is budgeted for 10 hours per week at an hourly rate of \$25.00 for a budget need of \$13,000 in year one. Weekly hours are expected to increase to 15 hours in year two and 20 hours by year three. Also included in the budget goal are consulting services of \$2,000 for resources such as legal and financial needs.

4. Memberships and Collaboratives \$500 for year 1

As the senior citizen population grows nationwide, there are increasing senior service organizations that provide invaluable resources and training for the deployment of education and services to our senior population. Similarly, there are a growing number of collaborative groups that the HSN would benefit from participating in. The budgeted amount for this line item provides limited funds for memberships or participation in these collaboratives or membership organizations. Examples of organizations include the regional Council on Aging, Summit County Senior Services, Village to Village, which is a nationwide grassroots organization, etc.

5. **Snowplow Program** \$30,200 for year 1

Several surrounding communities offer snowplow programs with restrictions based on age, income, housing, needs, and other restrictions (Appendix L). Surrounding cities fund this type of program with various sources (i.e., tax levies, municipal budgets, etc.). The intent of our goal for this program is to allow safe entrance to a house by EMS, Fire, and Police in the winter months.

The HSN goal is to have a snowplow program in place for the winter of 2023/2024. This program will take planning, outreach, and determination. The HSN is proposing a private contractor to perform the snow removal based on criteria to be determined during the planning stages. This program would be bid out like the City's cul-de-sac snow removal program. The estimated private contractual service budget is \$30,000 based on other community programs. Additionally, \$200 in year one is for planning purposes.

Criteria to consider for the senior snowplow program includes, however, is not limited to:

- Residents 65 and over.
- Homestead Tax.
- First come first serve.
- Number of 'vouchers' per household.
- Age restriction.
- Income restrictions.
- Depth of snow, parking bans, etc.
- Bid process of private contractual snowplow services.

6. Senior Center

Unfunded – Comprehensive Plan Discussion Item

Our programs and special events currently use the three community rooms, kitchen, and a storage area at City Hall which we are grateful for. As our programming expands over the years, our goal is to provide more frequent simultaneous programming, a designated space for seniors to drop by at their convenience and have coffee, socialize, take strengthening, and balance classes, etc.

As mentioned in the introduction, this is a perfect time to raise the question of the need for a senior center as the Comprehensive Plan update is currently beginning community discussions on future needs within the City of Hudson. A senior center should be included as part of that community input and feedback.

A projected cost for a senior center has not been provided as the space needs and cost of construction have not been determined and is therefore left blank in the unfunded column of the 5-year Business Plan Goals.

7. Social Service Support

\$5,000 Placeholder, Unfunded – Comprehensive Plan Discussion Item

Currently there are several groups in Hudson providing services to our senior citizens. Through grant funding, the City has been able to provide items such as smoke detectors, Knox boxes, bed shakers, and carbon monoxide detectors to a limited number of senior citizens. Other groups such as EMS Outreach, a not-for-profit organization, works to raise funds to fill gaps in what the City can provide however, the main gap is social service funding of programs such as counseling resources and referrals, bereavement support, respite support, etc. The Ministerial Association provides services, though not limited to seniors and is very limited on resources. The local food bank also provides a limited number of needed resources.

Since the City of Hudson is beginning community discussions on future needs for the Comprehensive Plan, this topic should be included as part of community input and feedback.

The HSN sees a future need for this type of service provision for senior citizens to be coordinated so all entities understand what the others are doing thus eliminating duplication and providing services where there may be gaps. This is a future need and is therefore included in the "unfunded" column with a placeholder budget amount.

Summary

The 5-year Business Plan Goals provide services and programming for the growing over 65 population in Hudson. The HSN has worked diligently over the past 4+ years to build an organization that is respected and trusted to provide services and resources to Hudson's seniors. Likewise, the Hudson Senior Citizens group has also done the same. Both efforts have been achieved with 100% volunteer coordination. As the needs of our senior population grow, it is time to expand our resources beyond the volunteer capacity.

Partnerships are an important element of the growth and sustainability we have had to date. Other community organizations assist in getting information out to seniors that subscribe to their respective "e-mail subscribers". Organizations such as the County, the Council on Aging, and Village to Village, are just a few who have provided advice. Surrounding Senior Centers and Services have also provided valuable knowledge to what and how a senior citizen entity works. Our local senior housing and health facilities have partnered with us providing lunches and refreshments for our educational programs. All partnerships are expected to continue as we build and expand on a Hudson Senior Network the community can be proud of supporting.

We thank Mayor Anzevino, City Council Members, and the community at large for your consideration on supporting our senior citizens in Hudson.

A Short History of the Hudson Senior Citizens

The first organizational meeting of the Hudson Senior Citizens was held on Friday, November 10, 1967. A group of about 30 residents met at the Hudson Library to select a name and elect officers. The first chairperson was Lola Daugherty, with Gladys Lewis as secretary and Ellen Mickel as treasurer. Many types of possible activities were discussed. A slide program by Chandler Jones of his trip to Spain, Portugal and Majorca concluded this first meeting

A second meeting was held on December 15, 1967 at the Hudson Library. At this meeting the name was officially chosen as Hudson Senior Citizens. A set of bylaws was discussed. Also at this meeting, the Hudson Community Service Association was asked to sponsor the the organization. The Community Service Association has since helped support the group with United Fund allocations.

Over the years, many persons have joined the group, attracted by frequent activities including trips to Cedar Point, Sea World, Salt Fork, Marietta, and Blossom just to name a few. In addition to the trips, the group for many years met at the Congregational Church meeting room for potluck luncheons.

The first meeting at the Memorial Room of the new Barlow Community Center was held on Friday, December 12, 1980. All of the following meetings have been held at the Barlow Center. The present activities of the group include several trips throughout the year as well as potluck luncheons at the Barlow Center.

To quote Ada Cooper Miller, who has been president three different times "We try to keep everyone young. This is not really a senior citizens group. We're Active". Ken Fligor adds the following comment, "When you retire you've got to keep busy. You can't just sit down in a rocking chair and go to pieces".

The group meets at the Barlow Community Center on the second Friday of each month at 12:30 P.M. Scheduled trips may affect this meeting date.

Appendix B

Agreement

This Agreement, effective <u>Nurember 9</u>, 2022, by and between the Hudson Senior Network, a 501 (c) 3 non-profit organization, and the Hudson Senior Citizens, organized in Hudson, Ohio, each a Party and collectively, the Parties, agree as follows:

As representatives and Directors of the Hudson Senior Citizens, Cindy Suchan Rothgery and James Rothgery, and Co-Chairs of the Hudson Senior Network, Rich Piekarski and Heidi Schweighoefer, agree to incorporate the Hudson Senior Citizens group's programming into that of the Hudson Senior Network.

The functions and activities of each group will remain unchanged. Residents of Hudson who may be interested in the activities sponsored by either group may attend and participate in either or both groups' respective activities. The dates and the locations of each groups' activities, and any associated fees, may differ, depending on the planning and scheduling of each group.

The Hudson Senior Citizens group will continue with an independent executive committee, but Cindy Suchan Rothgery will function as a liaison between the Hudson Senior Network and the Hudson Senior Citizens group.

The Hudson Senior Network has incorporated the Hudson Senior Citizens into their 5year plan and will assist the Hudson Senior Citizens, via donations, purchases of supplies for lunch programs, and speakers as needed, with an annual donation of five hundred dollars (\$500) per year.

The name "Hudson Senior Network" will refer publicly to both Parties, effective upon the date of execution of this Agreement.

Seniors In Summit County

Summit County was home to approximately 100,000 seniors, defined here as people age 65 or older between 2015 and 2019. Those 100,000 people accounted for over 18% of Summit County's population on average during the past 5 years. Due to the aging of the Baby Boom generation, the percentage of seniors is expected to continue rising sharply in the coming years.





Figure 1: Seniors As A Percent of Total Population by Summit 2020 Cluster. Source: 2015-2019 American Community Survey (ACS), 5-year average.




Figure 2: Share of Population Over Age 65 in Summit County, 2010-2050 Projection. Source: Ohio Development Services Agency, 2015-2019 ACS 5-year average.

Senior Population Projections -- Estimates of the 65 and older population for all Ohio counties published by the Ohio Development Services Agency projects Summit County's senior population to peak in 2035 at about 22% of the total population; nearly 116,000 people. Summit County's senior population appears to be growing at a faster rate than the ODSA projection based on current American Community Survey estimates (Figure 2). ODSA projections have Summit County reaching 100,000 seniors in 2021; ACS figures show the county was already within 100 people of reaching that number in 2019.

Senior Demographic Profile

Figure 3 presents a comprehensive demographic profile of the 65 and older population in Summit County from the 2015-2019 American Community Survey (ACS). Details on several indicators can be found below:

- Age. sex, and race-- The median age ofseniors in Summit County is 73.2 years;lower than 2010's figure of 75.3. This declinewas due to the rapid increase in the 65 andolder population caused by the aging of theBaby Boom generation. Most seniors arefemale (57%), which is higher than the totalpopulation figure of 51%. A higher percentageof seniors are white (87%) than the totalpopulation (79%). Only 11% of seniors areAfrican-American; lower than the percentageof African-Americans in the total population(15%). Asians make up 1.6% of the 65 and olderpopulation; about half their proportion in thetotal population (4%).
 - Disability status -- Nearly one-third of seniors (29%) have at least one disability. Of those with a disability, 43% have an ambulatory disability, while 18% have a cognitive disability, and 31% have a disability that makes independent living difficult or impossible. Other disabilities include self-care (16%), hearing (26%), and vision (12%).
- <u>Housing and households</u> -- About half of seniors (51%) live in a household with at least one spouse or family member, while nearly half (47%) live in a one-person household. More seniors live in owner-occupied housing than the general population (78% and 66%, respectively). Nearly 22% of seniors rent.

Other important demographic characteristics of seniors in Summit County include:

 Income and poverty -- More than 8% of seniors live below the poverty line in Summit County; about 8,000 in all; half as high as the rate for the county as a whole (14%). Most of the difference in poverty rates can be explained by the impact of social safety net programs like Social Security, Medicare, and others that benefit seniors. In fact, a November 2018 study by the Center for Budget and Policy Priorities entitled "Social Security Lifts More Americans Above Poverty Than Any Other Program" estimates that the nationwide 2019 poverty rate for seniors would have risen from 8% to over 38% in the absence of Social Security benefits.¹

Sources of income for seniors: Nearly all seniors in Summit County receive Social Security income (89%), while 67% receive other forms of retirement income. Social Security benefits averaged \$20,846 per year, while other retirement sources averaged \$26,172. More a third of seniors receive earned income (39%), while 9% received benefits from the SNAP program. Five percent received Supplemental Security Income (SSI), while 2% got cash assistance.

 <u>Employment</u> -- Nearly 10% of Summit County seniors worked full-time in the past 12 months, while 13% worked part-time. The vast majority, 78%, did not work at all.




Figure 4a: Senior Employment Status, 2015-2019. Source: 2015-2019 American Community Survey, 5-year average.

Younger seniors (ages 65-69) worked the most, with 20% working full-time and another 20% working part-time. Only 5% of those age 70 and older worked full-time while 10% worked part-time (Figure 4b).

- <u>Household Income</u> -- The median household income for all seniors is just under \$45,000 per year; lower than the \$57,000 for all households.
- Mortgage burden -- In the years just before retirement (ages 60-64), 60% of owneroccupied homes are mortgaged. That percentage drops to 53% of occupied homes





Figure 4b: Senior Employment Status by Age Group, 2015-2019. Source: 2015-2019 ACS, 5-year average.

with a mortgage between ages 65 and 74, and again to 29% for those age 75 or older. According to the ACS, the median monthly cost for senior homeowners with a mortgage is \$1,098. Median monthly owner costs for seniors without a mortgage is \$476. Even without a mortgage, homeowner costs for seniors add up to more than \$5,700 anually. One-quarter of seniors who own their homes (24%) pay at least 30% of their income for mortgages and other housing costs.

- Renter burden -- Seniors who rent face an even greater housing cost burden. More than 53% of seniors who rent spend at least 30% of their income on rent; much higher than the rate for all Summit County residents (43%).
- A large part of the difference in the renter burden for seniors can be partially explained by their change in income. The median household income for those age 45-64 was \$68,228 in 2019; the highest of any age group. As noted earlier, the median household

income for those 65 and older was just below \$45,000. That's a 34% decline in median income when moving into retirement years; more than \$23,000 annually.

Unfortunately, monthly rental costs for seniors don't drop anything like enough to keep pace with their income loss. According to ACS data for 2019, median gross rent for all Summit County residents is \$815, vs. \$775 for those age 65 and older. That's a decline of only 5% as people move into their retirement years.








Figure 5: Household Income Sources for Seniors, Summit County 2015-2019 Source: 2015-2019 ACS, 5-year average



<u>Grandparents raising grandchildren</u> -- One of the more important social indicators the ACS tracks is grandparents raising their own grandchildren. Here in Summit County, an estimated 8,714 grandparents live in the same household as their grandchildren. Of that total, 3,031 grandparents were responsible for raising those grandchildren. Because unintended pregnancies can happen at very early ages (making people parents and sometimes grandparents begins at age 30. Of the 3,031 grandparents raising their grandchildren, just under 47% (1,423) are over age 60.

Among grandparents over age 60 who were raising their own grandchildren, 54% were doing so without the help of the children's parents. The burden of being responsible for raising a child not only puts physical and emotional stress on those seniors who are raising their grandchildren, but significant financial burdens as well. According to the ACS, the median household income of those doing so without the help of the children's parents is much lower than for grandparents who are getting that help (see Figure 7). The amount of time grandparents must commit to raising their own grandchildren can also significantly increase the stress seniors raising their own grandchildren face. According to ACS data, 41% have been responsible for raising their grandchildren for at least 5 years. A much smaller percentage (12%) have been responsible for 6 months or less.

Racial Differences Among Grandparents raising grandchildren -- Of the 459 African-American grandparents living in the same household as their grandchildren, half (50%) were responsible for raising those grandchildren. Nearly a third (31%) of the 3,900 white grandparents living with their grandchildren were also responsible for raising them.




Figure 8: Racial Differences Among Grandparents Raising Their Own Grandchildren, 2015-2019; Source: 2015-2019 ACS, 5-year average

Note: ACS estimates for the number of Asian grandparents raising their grandchildren is both low and statistically unreliable (an estimated 62 grandparents raising their grandchildren, plus or minus 58). Therefore, Asian estimates are not included in Figure 8.

Health Issues Among Seniors




Figure 9: Fall-Related Emergency Room Visits and Fatalities, 2014-2020; Sources: EpiCenter, Ohio Department of Health (ODH) death records

<u>Fall-related injuries</u> -- Between 2014 and 2020, Summit County seniors had over 42,000 emergency room (ER) visits for a fall-related injury; about an average of 6,100 per year (see Figure 9). Fall-related ER visits rose from just under 52 per 1,000 seniors in 2014 to 82 per 1,000 in 2019, before dropping to just 42.0 in 2020 (3,800 fewer ER visits).

Of those 42,000 visits, records for 2,800 visits included specific mentions of a head injury associated with the ER visit (which could either be a cause or consequence of the fall). Sixtysix of the records included specific mentions of traumatic brain injury (again, as either a cause of consequence of the fall). A total of 6,303 de-

identified individuals, about 15% of the total, visited an ER more than once for a fall-related injury. Eleven of those de-identified individuals visited an ER between 10 and 19 times for a fall-related reason. In addition to falls, other frequentlyoccurring reasons include lacerations (2%), ankle injuries (1%), and loss of consciousness (2.9%).

<u>Fall-related deaths</u> -- Between 2014 and 2020, 339 Summit County seniors suffered a fall-related death. While fall-related injuries rose steadily from 2015 to 2019, fall-related deaths moved in the opposite direction until 2019. Fall-related deaths dropped from 65 per 100,000 in 2014 (57 deaths) to 36 in 2019 (35 deaths); a 45% decline.

That pattern changed from 2019 to 2020, with fall-related death rates rising to 65 per 1,000 (65 deaths); an 81% increase in one year.

There are two likely explanations for the sharp decline in fall-related ER visits and the sharp growth in fall-related deaths among seniors appears to be related to the lockdowns necessitated by COVID-19 last year. First, it is possible that many seniors were afraid of going to an ER after a fall for fear of being exposed to COVID-19, significantly increasing their danger of dying from fall-related injuries. Second, the need for vulnerable seniors to avoid exposure to COVID-19 reduced opportunities for healthy physical activity. Normal activities such as shopping, walking, or participating in exercise classes were all negatively impacted by last year's movement restrictions.

Of the 339 deaths between 2014 and 2020, 252 were described in death certificates as either Other fall on same level or Unspecified fall. Frequentlymentioned specific causes included Fall from stairs (39 cases) and Fall from bed (23 cases). Other causes include Fall from chair, ladder or wheelchair (14 cases).

<u>Age of fall-related incidents</u> -- The average age of fall-related ER visits was 80.5 since 2014, while the average age of fall related deaths was 87.5.

<u>Alzheimer's Disease and Dementia</u> -- Between 2016 and 2020, there were 3,129 Summit County residents who died of either Alzheimer's Disease or dementia. The causes of death were evenly split between Alzheimer's Disease and dementia (51% and 49%, respectively). The vast majority of cases, 68%, occurred in the 85 and older population

(Figure 10). The youngest victim of either disease was 48, while the oldest was 107.

Figure 11 shows the age-adjusted death rates for Alzheimer's disease and unspecified dementia deaths. The rate has been steadily climbing along with the size of the senior population since 2007. Death rates for Alzheimer's / dementia grew by about 11% between the 2007-2010 and 2016-2020 time periods.




Figure 10: Alzheimer's and Unspecified Dementia Deaths by Age Group, 2016-2020; *Source: ODH death records*




Figure 11: Age-Adjusted Death Rates for Alzheimer's and Unspecified Dementia Deaths - 2007-2020; Source: ODH death records <u>The Impact of COVID-19 On Seniors</u> -- Not surprisingly, the arrival of COVID-19 significantly altered the life expectancy picture across the age spectrum. Overall, between 2019 and 2020, the estimated life expectancy at birth declined by a year and a half (from 77.5 to 76.0).

Between 2008 and 2017, Summit County residents who were 65 years old could expect an estimated 19.3 additional years of life. In 2020, that figure dropped to just 17.9; a decline of 14 months of life expectancy in just one year.





Figure 12: The Impact of COVID-19 On Life Expectancy Age 65+ by Age Group, 2019-2020; Source: ODH death records

Figure 12 presents the changes in estimated life expectancy at different ages for seniors between 2019 and 2020. The loss in estimated life expectancy for all seniors was nearly one year (10 months) in 2020. Those in the age 65-69 age group dropped the most (14 months), while those in the 85 and older category dropped the least (0.6 years or about 8 months).





Figure 13: Ten Leading Causes of Death Ranked For Those Age 35 and Older, 2020 Source: ODH Death Certificate Data, Centers for Disease Control and Prevention

Leading Causes of Death -- Figure 13 presents the top 10 leading causes of death since the beginning of the pandemic for each of the 6 age groups with at least one COVID-19 death in Summit County. The tremendous impact of COVID-19 is clear from looking at the table. In less than 18 months, the disease became a top 10 cause of death for Summit County residents age 35 and older. For seniors, COVID-19 is a top 3 cause of death, ranking just behind cancer and heart disease for those age 65-84, and behind only heart disease for those 85 and older.

<u>Age of COVID-19 Cases</u> -- Seniors account for 17% of all cases but 88% of the deaths, while adults age 18-64 account for 74% of the cases but only 12% of the deaths. Children make up 9% of cases but fortunately no deaths to date (Figure 14).

Long-Term Care (LTC) -- Owing to the generally advanced age and fragile health status of those living in LTC facilities such as assisted living or nursing homes, known LTC residents make up only 6% of cases but 57% of the total deaths due to COVID-19 (Figure 15).

According to the most recent census, 18% of Hudson s population is over 65 years old. Yet Hudson has never provided senior citizen services. The Hudson Senior Network was organized approximately 2 plus years ago as awareness in the community grew regarding the need for senior support services. The Network is housed under the 501c3 umbrella of the Hudson Community Foundation wherein it has a dedicated fund.

In the fall of 2021, the Network conducted a survey to determine priority needs of the senior population. The number one need was for educational programing. This grant application is seeking funding to provide 12 educational programs in the following areas:

Technology Household safety Scam prevention Health and Wellness Finance The educational sessions will include lectures and one on one consultations. Take aways such as blood pressure cuffs, nutrition advisories, technology devices will also be provided to those seniors in need of them. The following is a list of takeaway items and their estimated costs: Fire extinguisher @\$75 per unit Extension cords @\$10 per unit Medication and Health information pouch for the refrigerator @\$10 per unit Blood pressure cuff @\$40 per unit Breathing exercise machine @\$10 per unit Chrome book or iPad device @\$250 per unit Phone charging port with LED light @\$40 per unit Large read phone @\$150 per unit Magnifying glass @\$15 per unit Walking stick for balance @\$20 per unit Suction handles for bath or shower @15 per unit Marketing for these educational sessions will include mailers, one per guarter, outlining the upcoming sessions as well as registration information.

The attendees will vary depending on the topic, a maximum of 30 seniors per class will be the upper limit. This will ensure adequate time for individualized consultations. At 12 sessions, the estimated total clientele over the grant period would be 360.

SNOWPLOW ASSISTANCE PROGRAM

2022-2023 Winter Season

PROGRAM OVERVIEW

The program is designed to provide driveway and sidewalk snow removal services to residents who are either elderly or disabled and are experiencing true hardship circumstances.

The program will run from November 15, 2022 to March 31, 2023.

Applications are accepted on a first-come, first-served basis.

The program will remain open until it has reached its budgeted capacity <u>**OR**</u> November 18, 2022, whichever comes first.

Abuses of this program will result in the termination of service.

SIDEWALK SNOW REMOVAL

Stow-Munroe Falls High School student volunteers will clear sidewalks for participants in the program.

Sidewalk snow removal services include:

- Sidewalks parallel to the roadway; and
- For detached garages, one sidewalk or path (4' width) connecting the house to the driveway.

This service will begin automatically whenever snowfall from a single snow event exceeds four inches (4") City-wide as determined by the City of Stow for a maximum of six (6) snow events. There is no need to call to activate this service.

DRIVEWAY SNOWPLOWING

Driveways will be plowed using a voucher system:

- Approved participants will receive six (6) snow plow vouchers to use at their discretion this winter season. Since every household has different needs, participants may choose when to use the vouchers.
- To receive snow plow service, participants call their assigned contractor, sign and date a voucher, and place it in their front screen door or a door closest to the driveway for the plow driver to retrieve.
- Vouchers should be used carefully and extra care taken so they are not misplaced. If a
 participant misplaces or runs out of vouchers, the contractor will expect full payment at the
 time of service.
- The City cannot issue additional vouchers or replace vouchers that are lost.

The contractor will make one (1) pass on a single car driveway, and two (2) passes on a double car driveway. The driveway apron and the length of the driveway will be plowed.

For residences with multiple driveways or garages, only the driveway to the garage closest to the street will be plowed.

Snow will be deposited within the tree lawn or along the left side of the driveway within the property. If snowfall is excessive, snow may be placed in the yard.

The contractor will <u>not</u> plow edge to edge, salt surfaces, or clear snow from patios, decks, bump out driveways, or around mailboxes.

It may take up to twelve (12) hours from the time the contractor is called until the driveway is plowed. Be sure to plan accordingly.

The private contractor is responsible for any property damage caused by this service.

ELIGIBILITY REQUIREMENTS

Applicants must meet <u>ALL</u> of the following criteria in order to be eligible for this program:

• 65 years of age or older **OR** totally and permanently disabled.

A written excuse from a licensed physician or a certificate of disability from the Social Security Administration for the individual(s) in the household who is under the age of 65 and disabled must accompany the application.

• The annual combined gross income of all household occupants (including seniors, disabled, and other occupants), must be less than the amount listed below. If <u>all</u> occupants of the household are 75 years of age or older, the income criteria is waived.

- There must not be an able-bodied person between the ages of 13 and 65 residing in the house.
- This service will be provided to qualified residents living in a single family home or two-family home with a separate driveway for each unit. Apartment buildings, condominiums, and mobile home communities are not eligible for this service as landlords and homeowner's associations, respectively, are responsible for clearing all driveways, parking lots and sidewalks.
- Applicants must reside in the home of the property address listed on the application all winter long. Vacant homes and homes where the applicants have left for the winter months are not eligible for this program.
- Driveways must be concrete or asphalt and in good condition. <u>Driveways or aprons containing</u> any portion of gravel, limestone, brick, or similar type driveways will not be permitted in the program.
- Program is not for "driveway aprons" only.

Snow removal services may be provided for Solon residents who are 65 years of age or over, or those residents who are classified as physically or mentally handicapped under the guidelines of the Social Security Administration, who have an annual gross household income of not more than \$40,000 per year including Social Security, pensions and interest with proof of gross income satisfactory to the Director of Senior Services, provided that no able-bodied person is residing with the resident at the same address. Each qualified resident must reside in the home for a majority of the winter months. Driveways will be staked by the first week of December by the plower.
- 2. No snow plowing will be furnished to qualified residents, except when the accumulation of snow reaches approximately 3 inches in one snowfall, as determined by the Service Director. Driveways shall be cleared not more than once in a 24-hour period.
- 3. **Snow removal vehicles will clear not more than a single driveway width.** Applicants shall not have side or overhead driveway obstructions which may interfere with snow removal operations. (Ord. 1990-160, passed 9/21/99; Ord. 2001-148, passed 7/2/01)
- 4. A City resident who qualifies for City snow plowing and who desires plowing services must complete, in person, an application at the Department of Senior Services. Any resident who is unable to appear in person may request the Senior Services Director to come to his/her home to complete the application.
