Mayor Shubert opened the public hearing for Ordinance No. 21-126 at 7:32 p.m.

Mr. Mike Jacobsen, representing Diebold Nixdorf, spoke in support of Ordinance No. 21-126 and the importance of having the company's logo on signage adjacent to the Ohio Turnpike. Mr. Tom Yankovich, of Ellet Sign Company, also spoke in support of the Ordinance, expressing the importance of allowing for clearer, more visible signage, viewable by motorists on I-80. He said that it is important to allow a different standard of sign illumination for this Zoning District, and internal illumination is much more clear from the highway. He provided an informational handout (attached to record copy of these minutes).

There being no other comments, Mayor Shubert closed the public hearing for Ordinance No. 21-126 at 7:38 p.m.

8. Correspondence and Council Comments

Mrs. Heater reported that she had met with Mr. Sandberg earlier this week to discuss the pickleball and tennis court initiative; with Mr. Stifler, who provided a tour of the City to discuss economic development; and with a Ward 1 resident to review safety issues as the intersection of W. Streetsboro Street/Atterbury Blvd./Milford Dr., and she suggested the City review this intersection for safety improvements. Mr. Foster agreed that safety is an issue at this intersection.

Mr. Banweg expressed interest in improving the State Routes 303/91 intersection for safety reasons concerning truck traffic. He also said that some residents have expressed concerns about Ordinance No. 21-71 regarding regulations for children's play equipment.

Mr. Foster read a letter on behalf of Mr. Sutton (attached to record copy of these minutes) concerning: potential brownfield remediation grant funding for the former Youth Development Center property on Hines Hill Road; appreciation of staff efforts to obtain Akron Metropolitan Area Traffic Study (AMATS) funding; and a request for disclosure and review of employee count impacts related to the proposed Western Reserve Hospital Building being recently downsized and the City's agreement to install a new water main for the hospital as an economic development incentive.

Mr. Foster also thanked staff members for their efforts to obtain AMATS funding.

Mr. Foster expressed gratitude to Mr. Vazzana for his service and commitment to the City of Hudson, as did Mrs. Kowalski and Mayor Shubert. Mr. Vazzana thanked elected officials and City staff, saying that it has been an honor to serve.

Mrs. Kowalski thanked staff for their responsiveness to her email requests.

9. Report of Manager

Ms. Howington reported that staff received recent notice of funding available for demolition and site revitalization through the Summit County Land Bank, for which an application was due today; and a Resolution will be included on the January 4th meeting agenda to affirm an application submitted by staff to fund the demolition of buildings at a recently acquired Ravenna Street property. She thanked staff for their quick response, which could save the City approximately \$90,000, pending the award of funding.

Mr. Sheridan reviewed several AMATS grant awards, pending final approval next month by the Policy Committee, including federal funding for various local projects: 1.) Congestion Mitigation/Air Quality Funding; 2.) Transportation Alternatives Set-Aside Funding; and 3.) Rails to Trails Funding. He said that staff will investigate other funding sources, as well.

Mr. Sheridan reviewed safety concerns at various intersections and said that the City will pursue Ohio Department of Transportation funding for safety improvements identified by recent studies.

Ms. Howington also expressed appreciation to Mr. Vazzana for his services and wished him well.

F. 21-160 AN ORDINANCE AMENDING PART TWELVE OF THE CODIFIED ORDINANCES OF HUDSON TO AMEND SECTION 1205.02, THE OFFICIAL ZONING DISTRICT MAP, OF THE LAND DEVELOPMENT CODE WITH RESPECT TO THE "HISTORIC DISTRICT" TO AMEND THE BOUNDARIES OF SAID DISTRICT TO INCLUDE ELM STREET AND ROSLYN AVENUE.
