

AN ORDINANCE AMENDING SECTIONS 220.01 AND 220.031(a) OF CHAPTER 220, "COUNCIL" OF THE CODIFIED ORDINANCES.

WHEREAS, this Council has reviewed its rules for its regular and workshop meetings and determined that for the convenience of the Council and the public, regular and workshop meetings of Council should be held on the same day of the week.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. Section 220.01, "Regular Meetings," of Chapter 220, "Council," of the Codified Ordinances is amended to hereinafter read as follows:

The regular meetings of Council shall be held in the Council Chambers at 27 East Main Street on the first and third ~~Wednesday~~ **Tuesday** of each month at 7:30 p.m., provided that in the event the date of any regular meeting falls on a holiday, Council shall, by a majority vote, set an alternative date according to the Charter.

Section 2. Section 220.01 as it existed prior to the effective date of this Ordinance, is hereby repealed.

Section 3. Subsection 220.031(a), "Workshop Meetings," of Chapter 220, "Council," of the Codified Ordinances is amended to hereinafter read as follows:

(a) In General. Workshop meetings of City Council shall generally take place on **the second and fourth** Tuesdays ~~on the weeks following the first and third Wednesday regular Council meetings~~ and shall be held at 7:30 p.m. The meetings will be held in the Meeting Room of the Town Hall, 27 East Main Street, or other location as decided by the President of Council. Workshop meetings are informal meetings of Council to discuss matters to be considered by Council at regular Council meetings or other matters concerning the City. All workshop meetings shall be open to the public in accordance with the Charter and statutes of Ohio providing for open meetings. Council shall take no legislative action at workshop meetings. Minutes of workshop meetings will be full and accurate minutes, which will enable the public to understand and appreciate City Council's discussion. The official minutes of workshop meetings shall be in the form as set forth in Section 220.03 and it shall be the duty of the Clerk of Council, or the Clerk's designee, to provide for and to produce the official

minutes for workshop meetings. Citizen comments will generally not be solicited at workshop meetings.

Section 4. Subsection 220.031(a) as it existed prior to the effective date of this Ordinance, is hereby repealed.

Section 5. This Ordinance shall take effect and be in full force and effect from and after the earliest period allowed by law.
