

AN ORDINANCE AUTHORIZING THE SALE OF A CITY FIRE ENGINE NO LONGER NEEDED FOR MUNICIPAL PURPOSES; AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined by the City Fire Department and City Manager that due to the replacement of an old fire engine, a 1994 Pierce Saber, the fire engine should be sold as it is no longer needed for municipal purposes; and

WHEREAS, various departments of municipalities in areas near Hudson have an initiative for regionalism and mutual aid between the City of Hudson and neighboring communities, which includes the sharing and/or sale of vehicles between those departments; and

WHEREAS, the City of Ravenna has committed to purchasing the above-described fire engine for \$32,000 and needs it as soon as possible; and

WHEREAS, the Hudson Fire Chief has researched similar used fire engine prices through various sources to determine that a fair market price for this fire engine to be the \$32,000.00 offered by the City of Ravenna and he is recommending that it be sold to the City of Ravenna for that amount on an “as-is” basis; and

WHEREAS, pursuant to its home rule authority as exercised through its Charter, the City of Hudson is selling this personal property which is no longer needed for municipal purposes;

NOW, THEREFORE, Be It Ordained by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: The City Manager is authorized to transfer title to the vehicle set forth in the preamble to this Ordinance for the sale amount of \$32,000.00 on an “as-is”, no express or implied warranty, basis to the City of Ravenna, Ohio.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Ordinance is an emergency measure necessary for the preservation of the public health, safety and general welfare and for the further reason that it is necessary to go into effect immediately upon its passage because the City of Ravenna needs to place the fire engine into service immediately to protect its citizens and property; wherefore, this Ordinance shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five members of Council elected thereto or six affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
