

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR BIDS AND TO ENTER INTO A CONTRACT FOR THE 2026 STORM SEWER AND CULVERT LINING IMPROVEMENTS PROJECT AND THE REPAIR OF A 78" STORM SEWER PIPE AT DARROW PARK WITH THE LOWEST AND BEST BIDDER.**

WHEREAS, the lining of City maintained storm sewers and culverts are in need of servicing and maintenance; and

WHEREAS, lining of the City's storm sewers addresses a safety concern due to the numerous sink holes and require continuous on-going maintenance requirements; and

WHEREAS, the lining process will eliminate future sink holes caused by separated joints and will extend the life of the storm system pipes; and

WHEREAS, after the pipe interior has been repaired, the City Public Works staff will restore any sink holes that remain in grass areas; and

WHEREAS, the estimated cost of lining and restoration work is \$250,000, including a 10% contingency; and

WHEREAS, the 78 inch metal storm sewer pipe, extending from Darrow Park to Lascala Drive, is a major component of the local storm sewer infrastructure was identified for remediation during a post-flood inspection in August 2024; and

WHEREAS, the estimated cost of 78 inch pipe repair project is \$100,000, including a 10% contingency.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to advertise for a period of three (3) weeks on the City of Hudson website requesting the submission of bids for the purpose of acquiring the lowest and best bidder in accordance with the specifications as supplied by the City Manager's office for the specified (a) 2026 Storm Sewer and Culvert Lining Project and (b) the Repair of a 78 inch Storm Sewer Pipe at Darrow Park Project as outlined in the specifications on file with the City Engineer.

Section 2. The City Manager is authorized to enter into contracts on behalf of the City with the lowest and best bidder on the subject and specified two separate projects, so long as the contracts are in a form satisfactory to the City Solicitor and subject to the affixing to the contract by the Finance Director of a certificate of availability of funds therefor.

Section 3. The City Manager is further authorized to return all certified checks and bid bonds submitted by the unsuccessful bidders.

Section 4. That the above recitals are fully incorporated as findings herein.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall be in full force and effect from and after the earliest period allowed by law.
