#### 6. Public Comments

Mrs. Kathleen Marsicano, 5236 Knollshire Drive, spoke on behalf of residents in her neighborhood. She expressed the need for sidewalks to improve safe access to Main Street for pedestrians and bicyclists from the Barlow and Terex Roads area. She also asked Council to consider providing access along Hudson Drive to the MetroParks bike trail, as well as completion of sidewalks along Main Street. Mr. DeSaussure commented regarding Council's recent adoption of a Connectivity Plan, saying that the City has devoted much time and effort to plans for improved connectivity for pedestrians and bicyclists. Mr. Schroyer promised to contact her to discuss her concerns and current plans for this area.

#### 7. Correspondence and Council Comments

Mr. Basil expressed thanks to Mr. Schroyer and Mr. Sheridan for their assistance and participation in the Ward 2 Open Forum, held on March 4, 2014.

Mr. Wooldredge reported on the Economic Growth Board meeting of February 27, 2014. He said there were pleas from businessmen in attendance for improved internet access and broadband. He noted that this matter is of great interest to the business community and would attract new businesses to Hudson.

Mr. Smith reported two resignations from the Park Board.

Mr. DeSaussure said that the City of Hudson relies on volunteers to serve on boards and commissions, and applications will be accepted through March 28, 2014, for current vacancies on the Personnel Advisory and Appeals Board, the Tree Commission, and the Park Board. He encouraged interested citizens to apply.
