AN ORDINANCE AMENDING THE CITY'S PAY RANGE STRUCTURE ADOPTED BY ORDINANCE NO. 13-156, PASSED DECEMBER 18, 2013; AND DECLARING AN EMERGENCY.

WHEREAS, Chapter 254 of the Codified Ordinances of Hudson, Ohio, provides that Council shall from time to time establish the ranges of compensation for City employees, and Council desires to amend the City's Pay Range Structure by adjusting the pay step amounts provided therein.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio, that:

<u>Section 1</u>: Effective as of January 1, 2015, the compensation ranges and associated pay steps provided in the Pay Range Structure and Assignments charts attached hereto and marked with the number of this Ordinance are hereby approved and established as the authorized and allowable compensation ranges and associated pay steps for all positions in the City that are not included in a collective bargaining unit.

<u>Section 2</u>: All Ordinance and Resolutions inconsistent herewith be and the same are hereby repealed but only to the extent that they are inconsistent with this Ordinance.

<u>Section 3</u>: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents and for the further reason that it is necessary in order to permit the adjustment to specified City employee compensation effected herein to take effect at the earliest possible time and thereby provide for the continued efficient operation of City departments and offices; wherefore, it shall take effect and be in force immediately upon passage, provided it receives five (5) affirmative votes of
