## PUBLIC HEARING NOTICE

Pursuant to Sections 1203.02(e)(3), 1203.03(b)(1)(B), and 1203.13 of the Land Development Code of the City of Hudson, Ohio, the Council of the City of Hudson will conduct a virtual public hearing at 7:30 p.m. on Tuesday, January 5, 2021, on Ordinance No. 20-167 entitled “AN ORDINANCE AMENDING PART TWELVE OF THE CODIFIED ORDINANCES OF HUDSON TO: (1) AMEND THE OFFICIAL ZONING DISTRICT MAP TO REZONE CERTAIN LANDS ON HUDSON DRIVE (SUMMIT COUNTY TAX PARCELS 3001315 AND 3001316) FROM DISTRICT 8, INDUSTRIAL/BUSINESS PARK, TO HIKE BIKE (HB) SENIOR HOUSING OVERLAY ZONING DISTRICT 8 AND (2) AMEND SECTION 1205.11(f)(1), “PURPOSE OF OVERLAY ZONE”, TO ACCOMMODATE THE ABOVE ZONING DISTRICT MAP AMENDMENT.”
