Mr. Sugar introduced the application noting: The front entryway redesign, questioned if the the roof pediment should be lowered, the treatment that ends near the outside corner which

typically goes to an inside corner, the window in front of the staircase questioning whether a more traditional window should be used and the brick pilaster used near the entry.

Board members and Mr. Peterson discussed the staff comments regarding the false covered walkway terminus, the muttons in the windows, the windows near the building entrances, the window above the front entry and its need for trim.

Ms. Marzulla made a motion to accept the application as submitted with the condition that the half-round window above the entrance be trimmed out. Mr. Caputo seconded the motion. The motion was approved by the following vote:
