A RESOLUTION ACCEPTING THE RECOMMENDATIONS OF THE TAX INCENTIVE REVIEW COUNCIL TO CONTINUE COMMUNITY REINVESTMENT AREA AGREEMENTS AND JOB CREATION GRANT PROGRAM AGREEMENTS WITH THE CITY OF HUDSON, COUNTY OF SUMMIT; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hudson has previously entered into Community Reinvestment Area ("CRA") agreements under State law with various businesses for the abatement of the businesses' real property taxes as incentives for the businesses to invest in the community; and

WHEREAS, the City has established a Job Creation Grant Program to provide economic incentives to businesses to locate within, retain, create, and expand employment opportunities within the City; and

WHEREAS, the City has established a Tax Incentive Review Council ("TIRC") which periodically reviews each CRA and Job Creation Grant agreement, to review each business's compliance with each agreement, and to make a recommendation to continue, modify or terminate each agreement; and

WHEREAS, the duly appointed TIRC met on October 2, 2012, reviewed each CRA and Job Creation Grant agreement, reviewed each business's compliance with each agreement, and made certain recommendations to this Council whether to continue or terminate said agreements.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio:

<u>Section 1</u>. That this Council accepts the recommendation of the TIRC that the following Community Reinvestment Area agreements be continued because the continuance of the agreements are economically beneficial for the residents of the City of Hudson and Summit County:
