A RESOLUTION AFFIRMING THE ACCEPTANCE BY THE CITY MANAGER'S DESIGNEE OF A FIRE PREVENTION AND SAFETY GRANT FROM THE DEPARTMENT OF HOMELAND SECURITY THROUGH THE FEDERAL EMERGENCY MANAGEMENT AGENCY; AND DECLARING AN EMERGENCY.

WHEREAS, this Council passed Resolution No. 18-31 on March 6, 2018, authorizing the City Manager or her designee to submit an application to the Department of Homeland Security for a Federal Emergency Management Agency Fire Prevention and Safety Grant to help fund a fire prevention program for at-risk senior citizen population, which would include installation of residential key security boxes and smoke detectors for the hearing-impaired in up to one hundred (100) homes; and

WHEREAS, the Department of Homeland Security, through the Federal Emergency Management Agency ("FEMA"), awarded Hudson Fire with said grant on September 10, 2018, in the amount of forty-seven thousand forty-eight dollars (\$47,048.00) to be used towards smoke detectors, hearing impaired smoke detectors and residential key security boxes for fire prevention programming for the at-risk senior citizen population and other qualifying residents; and

WHEREAS, the FEMA Fire Prevention and Safety Grant Program requires a five percent (5%) match from the City in the amount of two thousand three hundred fifty-two dollars (\$2,352.00); and

WHEREAS, this Council wishes to affirm the acceptance of said grant.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1. This Council affirms acceptance by the City Manager's designee of funding by the Department of Homeland Security, through the Federal Emergency Management Agency for a Federal Emergency Management Agency Fire Prevention and Safety Grant in the amount of forty-seven thousand forty-eight dollars (\$47,048.00) with a five percent (5%) match from the City in the amount of two thousand three hundred fifty-two dollars (\$2,352.00) for the purpose set forth in the recitals of this Resolution.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This Resolution is declared to be an emergency measure necessary for the preservation of the public health, safety, and general welfare of the City and its residents and for the reason that it is necessary to begin training, marketing and purchase of supplies in order to meet the grant period of performance deadline of August 21, 2019; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five members of Council, except that six affirmative votes shall be required if all members are present; otherwise, it shall be in full force and effect from and after the earliest period allowed by law.
