## 6. Correspondence and Council Comments

**Council President DeSaussure established the 2015 Ad Hoc Finance Committee of Council, and he appointed the following Council members to one-year terms: Dan Williams, Alex Kelemen, and Keith Smith. He said that the Committee will be tasked with working with the City Manager to identify opportunities to restructure the City's administration to accomplish and identify methods to achieve highest service at lowest cost to the City and to continue the work of the 2014 Ad Hoc Finance Committee.**

**Mr. DeSaussure announced the following changes in Council member assignments for 2015:**

**Park Board: Dennis Hanink, Council Liaison**

**Board of Zoning & Building Appeals: Keith Smith, Council Liaison**

**Architectural & Historic Board of Review: Hal DeSaussure, Council Liaison**

**Mr. DeSaussure said that all other Council liaison and representative assignments will remain unchanged from 2014, details of which are provided in the Council meeting minutes of January 15, 2014, and December 3, 2014 .**

*Mr. DeSaussure said that he had attended a funeral last week of a recent Hudson High School woman graduate who had tragically died from a heroin overdose. He reported that since 2012, the community has lost three recent Hudson graduates, and over the last four months there have been four other people in Hudson who have died from heroin overdoses. He said that the prevalence of heroin addiction is high in Hudson and in northeast Ohio, and he encouraged discussion and attention to this problem, so as to realize its scope for our community, and to strive to address this crisis of epidemic proportions. He asked the City Manager to work with the safety forces and asked citizens to provide input regarding a solution. Mr. Wooldredge agreed and said that alcohol and other drug abuse is also a serious problem. Mr. Basil agreed and suggested that the "Keep Hudson Safe Initiative" can address these problems. Mr. Hanink agreed and said that substance abuse is an ongoing issue, brought to the community's attention in recent years by the Schools' administration. Mayor Currin said that there is a call for the community to address drug and alcohol abuse problems responsibly, to come together, to provide support, to seek solutions, and to create and maintain a culture of health and well-being in Hudson.*

*Mr. Smith said that, given current decreased oil prices and low interest rates, he has asked the City Manager to consider expanding the roads program, adding trails, and adding cart paths at the golf course.*

*Mr. Wooldredge noted that the utility billing delinquency figures provided in the November Financial Report have substantially increased in the last few months, and he asked what this may be related to. Ms. Howington said that she will work with the Finance Director and will provide a report to Council.*

## 7. Report of Manager

*Ms. Howington thanked Mr. Paluscsak and Hudson Cable TV staff, who worked very hard over the holidays to complete a project to upgrade cameras and microphones in the Town Hall meeting room. Mr. Paluscsak spoke about the new equipment, control room, and graphic enhancements. He thanked Mr. Gary Dixon, who was volunteering his time this evening and using his audio expertise to balance equipment in the room. He thanked Mr. Comeriato, Mr. Munn, and Public Properties Division staff for assisting with maintenance work and painting, he thanked Mr. Gerbracht and other HCTV staff for assisting with equipment installation, he invited Council members to visit the new control room after the meeting, and he thanked Council for their financial support. Mayor Currin expressed appreciation for Mr. Paluscsak's leadership to provide public recordings of local government meetings.*

*Ms. Howington noted that the State of the City Report will be provided at end of January.*

*Ms. Howington said that Council members had requested an Economic Development Year-End Report, and she noted important elements of successful economic development and the varied approaches used by the City. Mr. Wiedie provided an overview of 2014, which included 26 new Hudson businesses with more than 70 new jobs, successful business retention efforts, a vibrant downtown, the transition of the Evaporator Works from office space to retail, and 100% occupancy of First & Main office space. He noted that Phase II of the Downtown Project will provide additional office space. He spoke of the City's outreach program to realtors, developers, and regional economic development partners, the marketing and broadband initiatives. He said that the Economic Development Year-End Report will be available via the City's website.*

**Executive Summary:** The Hudson Public Power staff has been working in cooperation with electrical design Engineers and the City's legal department to establish a formal interconnection policy and agreement to allow residents and/or businesses to interconnect privately owned solar power generation systems to the Hudson Public Power grid thereby allowing the customer to return unused solar generated electricity back to the power grid and realizing an account credit for the metered return amount (kWh). Public Works staff wishes for City Council to adopt the proposed policy for implementation.
