1. Call to Order

Mayor Basil called to order the regular meeting of Hudson City Council at 7:00 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Executive Session

A motion was made by Mr. Wooldredge, seconded by Mrs. Bigham, to enter into executive session to interview applicants for the Environmental Awareness Committee. Mayor Basil recessed the meeting at 7:01 p.m. after the motion carried by the following vote:

6. Public Comments

Mr. Chris Foster, 7303 Walters Road, spoke in support of City Council passing Ordinance No. 19-153, authorizing the 2020 Budget, although he urged certain adjustments be made in the upcoming year to increase funding for the Road Program.

Mr. Donovan Husat, 5761 Nicholson Drive, spoke highly of the service and commitment of Hudson's public officials. He thanked all for their dedication to making Hudson a great community, especially Mayor Basil, and Council Members Kelemen, Hanink, and Radigan as they leave their respective offices. He thanked them for their support of the Hudson Heritage Association and the Baldwin-Buss House Foundation, and he hoped that their successors will serve Hudson with the same level of dedication and commitment. In addition, he provided a brief update regarding fund-raising efforts for the Baldwin-Buss House.

7. Correspondence and Council Comments

Mr. DeSaussure spoke regarding Mayor Basil's service, saying that it has been a pleasure to work with him and describing him as a consummate professional. He stated that the Mayor's role in Hudson is not one of chief executive officer but of chief civic officer. He noted Mayor Basil's engagement with the community through his service on Planning Commission, City Council, and as Mayor; and he acknowledged his leadership with Senior Advisory Committee. Mayor Basil said that it is an honor and pleasure to work with all City Council members.

Agreeing with previous comments, Dr. Williams spoke with similar praise of Mayor Basil, expressing appreciation for his gentlemanly nature and thanking him for his service. He noted the amount of time sacrificed by public officials, and he thanked Mrs. Basil for sharing her husband. Mayor Basil thanked him and noted that he will share comments at the end of the meeting.

As Park Board Liaison, Mr. Hanink provided an update regarding the regrading and improvements to the baseball fields. He also reported on an excellent season at Ellsworth Meadows and a substantial financial improvement compared to last year in spite of the wet spring weather, due in part to improvements at the golf course. Finally, he said that the Park Board has formally embraced the notion of turning Darrow Road Park into a pollinator meadow, which signals a broadening of the Park Board's thinking. He supported the Park Board's role in such conservation and restoration efforts.

Mayor Basil shared a note received from a motorist, who wrote in appreciation of Hudson's excellently

maintained roadways during inclement weather. He acknowledged the efforts of City staff and Public Works Department employees, who do a superb job, and he asked Mr. Comeriato to pass along this thanks to his employees.

Mayor Basil shared the status of various projects with the Senior Advisory Committee, announcing that the Committee has reviewed the community survey results and has decided to schedule programming and events for seniors on the first and third Fridays and second and fourth Wednesdays each month between 11 a.m. and 2 p.m. He said that programming and events will be hosted by the Senior Advisory Committee at the new City Hall community rooms, and the first event is scheduled on February 12, which will be a lunch and learn program. He announced that he has transitioned the leadership of the Senior Advisory Committee to the City Manager, and he thanked Ms. Howington for agreeing to take on this task. Finally, he noted that meetings on the Senior Advisory Committee will continue on the second and fourth Wednesdays of each month.

8. Report of Manager

Ms. Howington said that the City Manager's Office is working with the following committees: Senior Advisory Committee, NextGen Committee, Technology Committee, and Youth Group. She expressed a desire to create intergenerational dialogue and networking among these groups, and she promised more information to come.

She commented that the City's staff is incredibly dedicated. She then shared a letter from a long-time EMS volunteer, who praised the EMS leadership, noting that the morale of the department has skyrocketed in recent years, and Hudson EMS is making a significant effort in training its EMTs for future success. She said that EMS volunteers have a long history of giving back to the community, and she acknowledged Chief Varnes and Scott Vargo for their excellent leadership.
