

RESOLUTION NO. 14-99

OFFERED BY: MAYOR CURRIN

A RESOLUTION PERMITTING BOW HUNTING OF DEER ON THE FORMER YOUTH DEVELOPMENT CENTER (“YDC”) PROPERTY LOCATED ON CERTAIN PROPERTY AT 996 HINES HILL ROAD.

WHEREAS, pursuant to Chapter 1074 of the Codified Ordinances, this Council provided for the regulated bow hunting of deer in certain areas within the corporate limits of the Municipality, in order to reduce the number of deer within the municipality so as to deal with problems caused by an overpopulation of deer associated with vehicular safety on public rights of way, damage to private and public properties related to landscaping, trees and other vegetation, and public health concerns with respect to diseases transmitted through deer populations to humans; and

WHEREAS, the City has an equitable ownership interest in, and effective control over, the property at 996 Hines Hill Road, known as the former YDC property; and

WHEREAS, it has been recommended by City staff, as reviewed by this Council, to permit bow hunting of deer at the areas on the south side of Hines Hill Road of the YDC property and under the regulations established by Chapter 1074 and such activity is not prohibited by the conservation easement and other restrictions that have been placed upon the aforesaid property.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, State of Ohio, that:

Section 1: The City of Hudson hereby consents to and authorizes bow hunting of deer under the regulations set forth in Chapter 1074 of the City’s Codified Ordinances within the area set forth on the map attached hereto as Exhibit A and fully incorporated by reference herein.

Section 2: The map attached hereto as Exhibit A shall be published to the public through appropriate means as is determined by the City Manager.

Section 3: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
