AN ORDINANCE AMENDING SECTION 410.01 OF THE TRAFFIC CODE TO REMOVE SPECIFIC REFERENCES TO SCHOOL ZONE SPEED LIMIT AREAS.

WHEREAS, school zone speed limits are governed by Title Six, "Operation and Vehicles" of the City of Hudson Traffic Code and the Ohio Revised Code; and

WHEREAS, for purposes of clarity with respect to the City's school zone speed limit regulations, City Staff has recommended amending Section 410.01 in certain respects, including removal of reference to school zone speed limits within the City, which are otherwise regulated as noted in the above recital; and

WHEREAS, nothing in this Ordinance is intended to repeal, affect, and/or modify any existing school zone speed limits within the City of Hudson.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio:

That Section 410.01, "Schedule I – Existing Posted Speed Limits," is hereby Section 1. amended as follows:

"410.01 SCHEDULE I – EXISTING POSTED SPEED LIMITS. Following are the existing posted speed limits in the City:

Nothing contained in the schedule above shall affect and/or modify the speed limit regulations in any school zones throughout the City, and it is not the intent of this schedule to increase the speed limit in school zones during applicable school zone hours."

Section 2. That in all other respects, except as amended herein, Section 410.01 of the Traffic Code shall remain in full force and effect.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
