Members of the American Legion Auxilliary, Lee Bishop Unit 464, accepted this Proclamation. President Cindy Suchan-Rothgery thanked Mayor Basil. She announced that members will be distributing poppies, handmade by veterans, at Acme and Drug Mart on May 17 & 18, 2019. She urged everyone to support Poppy Days, and she invited everyone to attend or participate in the Memorial Day parade, attend a brief service at Markillie Cemetery following the parade to remember the men, women and their families who have made the ultimate sacrifice for our freedom, and to honor their sacrifice and pay tribute to them by wearing a poppy.

Mayor Basil read this Proclamation in its entirety, acknowledging Poppy Days.

#### 7. Public Comments

Mr. Jack George, 7590 Woodspring Lane, asked for confirmation of the amount of money proposed for the Skate Park Renovations Project. Ms. Howington provided an update on this project. Mr. George suggested that the City conduct a feasibility study to assess needs.

### 8. Correspondence and Council Comments

Mayor Basil spoke regarding some inaccuracies recently disseminated regarding City staffing and the City's purchase of the Youth Development Center property, formerly owned by Cuyahoga County.

Mr. Wooldredge directed remarks to and for City staff in response to Mr. Kelemen's April 24th Letter to the Editor that appeared in the Hudson Hub-Times. Mr. Wooldredge disagreed with Mr. Kelemen's comments, and he thanked City staff for their competence and dedication, as demonstrated by many performance measures, recognitions, and awards.

Ms. Radigan agreed with Mr. Wooldredge and thanked staff, as well, noting that she has found staff to be responsive and professional. She also invited interested citizens to attend a Ward 2 Open Forum at 2 pm on May 19, 2019, at the Veterans Way Park Playground.

Mayor Basil said that since his involvement with the City in 1998, staff has uniformly been professional, knowledgeable, and responsive. He thanked City staff for everything they do for the community.

# 9. Report of Manager

Ms. Howington thanked Mayor Basil and City Council members for the Public Service Week Proclamation, as well as their kind words and support of City staff.

She announced that the City's new salt dome and bus garage were completed ahead of schedule and under budget by over \$450,000. She encouraged interested citizens to attend an EMS Open House event at 11 am - 2 pm on May 19, 2019.

She responded to Mr. Hanink's request for staff to address Mr. Metcalf's recent Letter to the Editor in the Hudson Hub-Times regarding Velocity Broadband issues. She summarized the City's process of for responding to trouble calls. She said that often times customers' personal routers present issues, as was the case with Mr. Metcalf.

She announced that the Land Development Code rewrite, including administrative amendments, will be returning to City Council for a public hearing and discussion. She said that information will be posted on the City's website.

She said that the Tobacco 21 Initiative and the vaping issue will be scheduled for future workshop discussion.
