A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT FOR A PREFABRICATED PUBLIC RESTROOM STRUCTURE FOR THE BARLOW FARM PARK TENNIS AND PICKLEBALL COURTS IMPROVEMENT PROJECT; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hudson is authorized to purchase materials and related equipment through the Sourcewell Cooperative Purchasing Program;

WHEREAS, the City needs one (1) permanent, safe, and sanitary public restroom structure for use at the future Barlow Farm Park Tennis and Pickleball complex;

WHEREAS, acceptable prefabricated concrete restroom structures may be purchased from CXT Concrete Buildings at a proper and acceptable price through the Sourcewell Cooperative Purchasing Program.

NOW, THEREFORE, Be It Resolved by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: The City Manager is authorized to enter into on behalf of the City a purchase agreement with CXT Concrete Buildings in the amount of Forty-Thousand Dollars (\$40,000.00) for the purchase of one (1) prefabricated concrete public restroom structure for use at the Barlow Farm Park set forth in the recitals of this Resolution through the Sourcewell Cooperative Purchasing Program contract # 081721-CXT.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution is determined to be an emergency measure necessary to further the public health, safety and general welfare of the citizens of Hudson at the earliest time possible and for the further reason that this project requires the coordination of several construction activities within the City and the ability to timely secure materials and supplies, such as this prefabricated building, so that the project can be completed in the current construction season; wherefore, this Resolution shall be in effect immediately upon its passage provided it receives the affirmative vote of five (5) members of Council except that six (6) affirmative votes shall be required if all members are present; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
