A RESOLUTION AMENDING RESOLUTION NO. 22-78, AUTHORIZING THE CITY MANAGER TO REVISE THE PROFESSIONAL SERVICES CONTRACT WITH VIRTUAL DATAWORKS FOR THE MIGRATION TO THE MICROSOFT GOVERNMENT COMMUNITY CLOUD (GCC) AND ANNUAL SUBSCRIPTION RENEWAL FOR THE CITYWIDE USE OF MICROSOFT 365, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Charter Section 6.04, the City Manager previously entered into a contract in 2020 and 2022 with Virtual DataWorks for citywide use of Microsoft 365 software and associated professional support services; and

WHEREAS, Resolution No. 22-78, passed on June 7, 2022, Council authorized a contract in the amount of \$65,912.20; and

WHEREAS, the City staff has recommended that this Council authorize the City Manager to amend and update the existing said contract with Virtual DataWorks for three (3) years for ongoing software upgrades and associated professional services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

<u>Section 1</u>: The City Manager is authorized to enter a contract with Virtual DataWorks for citywide use of Microsoft 365 software and associated professional support services at an annual amount of not to exceed 10 percent (10%) over Eighty-Seven Thousand Two Hundred Eighty-Seven Dollars (\$87,287), totaling an amount not to exceed 10 percent (10%) over Two Hundred Sixty-One Thousand Eight Hundred Forty-Three and 00/100 Dollars (\$261,843) for the next three (3) year period.

<u>Section 2</u>: The City Manager is further authorized to renew the subject contract for annual renewal terms thereafter in an amount as appropriated by this Council and in a form acceptable to the City Manager and City Solicitor as necessary to maintain ongoing software upgrades and associated professional services during the next three (3) year period.

<u>Section 3:</u> It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: That this Resolution is hereby declared to be an emergency measure necessary for conformity with the Ohio Revised Code, the timely and immediate implementation of these necessary and important software and professional services upgrades, the preservation of the public peace, health, and safety of the City's residents, and to allow for the continued safe and effective operations of the City IT Department and other departments and shall, therefore, take effect and be in force from and immediately after its passage.
