

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH KARVO COMPANIES, INC. IN THE AMOUNT OF TWO MILLION FIVE HUNDRED FOUR THOUSAND SIX HUNDRED SEVENTY-THREE DOLLARS AND TWENTY-TWO CENTS (\$2,504,673.22) FOR THE STOW ROAD AND E. STREETSBORO STREET SIDEWALK INSTALLATION PROJECT; AND DECLARING AN EMERGENCY.

WHEREAS, the City has completed formal bidding pursuant to City Charter Section 6.04 and Resolution No. 22-169 for the Stow Road and E. Streetsboro Street Sidewalk Installation Project; and,

WHEREAS, this project would include improvements along E. Streetsboro Street (State Rte. 303) between N. Hayden Parkway and Stow Road, along E. Streetsboro Street from Stow Road to Stone Road and on Stow Road between E. Streetsboro Street and the entrance to Hudson Springs Park; and,

WHEREAS, after receiving bids on March 21, 2023, City Council determines that the lowest and best bidder is Karvo Companies, Inc. and that the City should enter into a contract with that company for the construction of the aforesaid 2.38 miles of concrete sidewalk and other improvements.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, as follows:

Section 1. The City Manager is authorized to sign all necessary paperwork to enter into a contract with Karvo Companies, Inc. in the amount of Two Million Five Hundred Four Thousand Six Hundred Seventy-Three Dollars and Twenty-Two Cents (\$2,504,673.22), which includes a 5% contingency amount, for the Stow Road and E. Streetsboro Street Sidewalk Installation Project.

Section 2. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and general welfare of City residents, and the timely completion of the work during good weather, and shall, therefore, take effect and be in force from and immediately after its passage.
