1. Call to Order

President of Council Wooldredge called to order the workshop of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

2. Correspondence and Council Comments

Mayor Shubert provided an update on his wife's health condition.

Mr. Foster provided an update on the Planning Commission meeting that was held on July 12, 2021.

Mrs. Bigham stated that she has heard from a resident regarding the positioning of the "No Turn on Red" sign at Library Street and SR 303. She also heard from a resident in regards to the automated answering service that is being utilized now when you call City Hall, and stated that the resident was very frustrated as it was very time consuming to utilize.

Ms. Schlademan provided an update on the Environmental Awareness Committee that was held on July 7, 2021.

Ms. Howington provided the reasoning for the automated answering service being utilized in Utility Billing. She also provided an update on the events planned for Labor Day weekend.

3. Discussion Items

A. 21-0057 Hudson Public Power 2021 Cost of Service and Electric Rate Study

Brief Description: The Public Works Department has contracted with Public Utility Consultants, Courtney and Associates to develop a cost of service and electric rate study and to make recommendations to City Council regarding future electric rates.

Mr. Courtney, Courtney & Associates, presented the Cost of Service and Electric Rate Study. Discussion included reason for increase of Operation & Maintenance costs, items included in Operations & Maintenance costs, unbilled losses, where Hudson stands compared to other communities, concerns with Prairie State, revenue compared to other cities and First Energy, fixed customer monthly fee, and proposed rate increase.

B. <u>21-0055</u> Stopped Train Warning Signals

Brief Description: Councilman Chris Foster has requested discussion regarding stopped train warning signals for the Hines Hill Road railroad crossing.

Mr. Sheridan provided an update and costs for several different options regarding the stopped train warning signal for the rail crossing on Hines Hill Road. Discussion followed that included use of cellular for the operation of the signs instead of hardwiring with Velocity Broadband, and costs involved in Option 4. Staff will report back to Council in August on the benefits of wireless vs. fiber and will begin a draft agreement with The Ohio Rail Development Commission for the portion of work that they have agreed to pay.

C. 21-0058 Update Stow Road and Middleton Road Intersection Study

Brief Description: The City's traffic engineering consultant, GPD Group, recently completed an updated study of the Stow Road and Middleton Road intersection. Upon completion of the study, staff indicated that it would discuss the results of the study with City Council.

Mr. Kosco presented information on the study that was performed on the intersection of Stow Road and Middleton Road. He stated that the study found that a traffic signal is warranted at this intersection and he proposed beginning the design this year with construction in 2022. Mr. Sheridan stated that the design fee can be taken from funds remaining in the Sidewalk Connectivity design fund. There was Council consensus to move forward with design in 2021.

The CMAQ funding request will be for, \$2,316,939 (80%), and the City would be responsible for the remaining \$579,234 (20%).

C. 21-74 AN ORDINANCE REPEALING SECTION 648.12 OF THE CITY'S GENERAL OFFENSES CODE REGARDING CONSTRUCTION WORK AT NIGHT.

Brief Description: Section 648.12 was adopted in 1992 and was superseded after merger with the adoption of the Land Development Code. Section 1207.10, Performance Standards, (a)(3)E regulates the permissible hours for the use of construction equipment or performing construction operations in Hudson, except for temporary conditions approved by the City Manager.
