Payment Terms

Payment of 25% of the contract price may be required with order. The contract balance is due no later than 30 days after invoice date.

Qualite will attempt to coordinate shipment so that delivery corresponds with the customer's payment schedule. We will expect payment within the terms described above unless there is a written statement from Qualite's corporate headquarters stating the acceptance of different terms.

- **Delivery to the job site from the time of order, submittal approval, and confirmation of order details including voltage and phase, pole locations is approximately 40-60 days (non-standard/rush delivery may be available at additional expense). Due to the built-in custom light control per luminaire, pole locations must be confirmed prior to production. Changes to pole locations after order is sent to production may result in additional charges.**

Notes

Quote is based on:

- Shipment of entire project to one location - pre-shipment of material/equipment or multiple shipments may incur additional expense
- Field size of 280' Radius for baseball per Qualite design Pro Series
- Costs are based on normal soil conditions and do not include costs for temporary caissons, dewatering, collapsing sand or rock drilling. Stamped foundation design can be provided upon order if site specific geotechnical report is provided.
- 240V Volt, Single Phase electrical system. Costs assume adequate power supply at site within a reasonable distance (< 300').
- Qualite is a material supplier only and any estimated install costs are based on projects with similar scope. A licensed electrical contractor should be consulted for cost verification.
