6. Proclamations

A. <u>14-0080</u>

Proclamation: Special Recognition of America Recycles Day 2014.

Executive Summary: Mayor William Currin will proclaim November 15, 2014, as "America Recycles Day" in the City of Hudson. Mrs. Leanne Schumacher, Environmental Awareness Committee (EAC) member, and Sonya Mottram, Public Works Support Supervisor, will be in attendance to accept the Proclamation on behalf of the EAC.

Mayor Currin thanked the Environmental Awareness Committee for their leadership in recycling endeavors. Mr. Resnick, Committee Chair, accepted the Proclamation and thanked Mayor Currin. Also in attendance were other Committee members, Mr. Peterson and Mrs. Schumacher, as well as staff member, Mrs. Mottram.

Mayor Currin read this Proclamation in its entirety, recognizing November 15, 2014, as "America Recycles Day" in the City of Hudson.

Executive Summary: Mayor Currin will proclaim the week of November 17 through 23, 2014 as "Global Entrepreneurship Week" in Hudson. Ms. Deborah Hoover, President, Burton D. Morgan Foundation, will be in attendance to accept this Proclamation.

Mayor Currin presented this Proclamation to Ms. Angela Kwallek Evans, who accepted it on behalf of The Burton D. Morgan Foundation. She thanked Mayor Currin and spoke of the importance of Global Entrepreneurship Week, noting the special events planned in Hudson. She encouraged citizens to involve their children and to visit the Library's website for detailed information regarding special events.

Mayor Currin read this Proclamation in its entirety, recognizing the week of November 17 through 23, 2014 as "Global Entrepreneurship Week" in Hudson.

7. Correspondence and Council Comments

Mr. DeSaussure announced that the City is accepting applications through November 26, 2014, for the following volunteer boards, commissions, and committees: Cemetery Board, Environmental Awareness Committee, Board of Zoning & Building Appeals, Planning Commission, Cable Television Advisory Committee, and the 2015 Charter Review Commission. Mr. DeSaussure and Mr. Basil spoke of the importance of volunteering and encouraged citizens to apply for the current openings.

Mr. Wooldredge said that he recently attended the Ohio Economic Development Association's Excellence Awards Program at which the City of Hudson was recognized for Excellence in Economic Development Marketing for its "Businesses Welcome, Workforce Ready" marketing campaign. Council members Wooldredge and Basil congratulated Mr. Wiedie for his efforts in this regard.

Mr. Basil thanked Mrs. Howington for participating in the Ward 2 Open Forum on October 28. 2014.

8. Report of Manager

Ms. Howington reported on key projects and programs. She said that the new City of Hudson entry signs, sponsored by Leadership Hudson, have been installed; the leaf collection program is underway, with record volumes collected; railroad track maintenance on Stow Road is completed, and the road is open to traffic; and City offices will be closed on November 11, 2014, for the Veterans Day holiday.

9. Presentations

A. Presentation: 2014 Environmental Stewardship Award to Taste of Hudson.

Executive Summary: Mrs. Leanne Schumacher, Environmental Awareness Committee member, requested that the 2014 Environmental Stewardship Award be presented at the November 5, 2014, City Council meeting. Andy Malitz, Executive Director, will accept the award on behalf of Taste of Hudson.

Mrs. Schumacher explained the criteria for this annual award and spoke of Taste of Hudson's efforts to recycle and reduce solid waste at this year's event. She presented the award to Mr. Andy Malitz, Executive Director, who spoke of the importance of recycling, as well as plans to incorporate composting for the 2015 Taste of Hudson. He said that this annual event is a collaboration among many organizations to showcase Hudson, and he noted that Taste of Hudson was able to donate \$23,500 this year to various community charities, as recently reported by the Hudson Hub-Times. Mayor Currin offered congratulations to Mr. Malitz and his team for their outstanding efforts.

Mrs. Leanne Schumacher, Environmental Awareness Committee member, recognized Taste of Hudson as the recipient of the 2014 Environmental Stewardship Award.

B. 14-0083 Presentation: Status of the Comprehensive Plan Update.

Executive Summary: Mr. Dan Gardner, principal of Houseal Lavigne Associates, who is leading the Comprehensive Plan update effort will make a brief presentation on the status of the plan.

Mr. Richardson described the process for updating the City's Comprehensive Plan and introduced Mr. Dan Gardner, who provided a status report. Mr. Gardner said that an Existing Conditions Analysis is currently underway, community meetings were conducted in September, and interviews with key community leaders are being conducted this month. He said that citizens will have opportunities in January to become involved in the planning stages, and he encouraged citizens to refer to the project website, linked from the City's home page, and to respond to the online survey. He said the process will continue over the next eight months, and the goal is to reflect the vision of the entire community. Discussion followed.

C. 14-118 Presentation: Community Development Block Grant Program.

Executive Summary: City Council has requested that a representative from Summit County provide information regarding the CDBG Program, pursuant to Resolution No. 14-118, entitled "A RESOLUTION AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE THE "FIRST AMENDMENT TO AGREEMENT OF COOPERATION COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM" WITH THE COUNTY OF SUMMIT; AND DECLARING AN EMERGENCY," which is currently tabled. Ms. Connie Krauss, Director of Summit County's Department of Community and Economic Development, and Ms. Holly Miller, Senior Administrator, will provide information and answer questions at the November 5, 2014 Council meeting.

CDBG Program Information Presented at 11-5-2014 Council Meeting

Ms. Connie Krauss provided an overview of Summit County's Community Development Block Grant Program and its goals of eliminating slum and blight, economic development, and providing benefits to low and moderate income individuals. Ms. Hollie Miller spoke regarding the County's consolidated spending plan for the CDBG Program and explained how grants benefit citizens, businesses, and communities. She provided a draft summary of the objectives and outcomes identified in the County's Plan Needs Assessment Overview (attached to record copy of these minutes).
