

RESOLUTION NO. 18-88

OFFERED BY: MAYOR BASIL

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH ACCEL BUILDING SYSTEMS, LLC FOR THE PURCHASE AND INSTALLATION OF A TEMPORARY SALT STORAGE STRUCTURE; AND DECLARING AN EMERGENCY.

WHEREAS, in preparation for the Downtown Phase II Project, City staff has ceased using the current salt storage structure located at 95 Owen Brown Street; and

WHEREAS, the City of Hudson's Service Department intends to install a temporary salt storage structure and associated components at 996 Hines Hill Road to accommodate salt storage for the upcoming snow season; and

WHEREAS, pursuant to the City Charter and ordinances and under State law, the City Manager may purchase goods or services through bids obtained by cooperative purchasing programs when authorized by action of Council – here, through the State Contract Pricing Program; and

WHEREAS, the City has obtained a quote from Accel Buildings Systems, LLC, under the State Contract Pricing Program, Contract RS904115, for the purchase and installation of a temporary salt storage structure in the amount of \$213,502.25.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, County of Summit, State of Ohio, that:

Section 1: The City Manager is authorized to execute on behalf of the City of Hudson a contract with Accel Buildings Systems, LLC., under State Contract Pricing Program, Contract RS904115, for the installation of a temporary salt storage structure to be located at 996 Hines Hill Road in an amount not to exceed \$234,852.48, which includes a 10% contingency amount.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare and for the further reason that it is immediately necessary to construct the temporary salt storage structure and associated

components in time for the upcoming snow season; wherefore, this Resolution shall be in full force and effect immediately upon its passage, provided it receives the affirmative vote of five members of Council elected thereto or six affirmative votes if all members of Council are present at the meeting at which it is passed; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
